Application is hereby made on behalf of **K. WILSON ENTERPRISES, INC.**, (Applicant), to the Commissioner of Conservation for a Public Hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Cockfield Stray Sand, Reservoir A, West Rogers Field, LaSalle Parish, Louisiana:

1. To permit the Applicant to designate and utilize an existing well bore, the K. Wilson Enterprises, Inc. – IPB-Norris No. 2 Well as an alternate unit well for the production of oil and gas for the Cockfield Stray Sand, Reservoir A, in the unit designated CS RA SUA, in the West Rogers Field, LaSalle Parish, Louisiana, such unit and well shown on the attached plat and being made a part hereof.
2. To find that an alternate unit well is necessary, at the location shown on the attached plat, to assist in draining a portion of the Cockfield Stray Sand, Reservoir A, in the unit designated CS RA SUA, that cannot be drained by any other well located within the unit.
3. To permit the unit operator to produce the assigned unit allowable from the unit well, the alternate unit well or from a combination of all wells, at its discretion.
4. To consider and cover such other matters as the Commissioner of Conservation may deem pertinent and appropriate.

The Cockfield Stray Sand, Reservoir A, in the West Rogers Field, LaSalle Parish, Louisiana, was defined in Office of Conservation Order No. 1211, effective December 9, 1982.

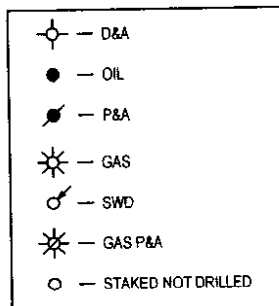
