

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JANUARY 11, 2011**, upon the application of **CHESAPEAKE OPERATING, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Spider Field, DeSoto Parish, Louisiana.

1. To create one (1) additional drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A.
2. To redefine the Haynesville Zone, INSOFAR AND ONLY INSOFAR as the proposed unit referenced herein is concerned, in accordance with the DEFINITION section hereof.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit, with each tract sharing in unit production on a surface acreage basis of participation.
4. To designate Chesapeake Operating, Inc. as the operator of and a unit well for the proposed unit, if appropriate.
5. To provide that with respect to horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve the proposed unit, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforation in the well and not based on the penetration point or terminus.
6. To extend to the proposed unit, to the extent not inconsistent herewith, all pertinent provisions of Office of Conservation Order No. 92-N, effective October 7, 2008, as amended and supplemented by the 92-N Series of Orders, and all applicable Statewide Orders.
7. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was previously defined in Order No. 92-N, effective October 7, 2008, and is hereby redefined INSOFAR AND ONLY INSOFAR as the proposed unit is concerned, as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 9,752' and 11,870' (electrical log measurements) in the Bidas Energy USA, Inc.-DeSoto Oil & Gas Trust 18 No. 1 Well, located in Section 18, Township 12 North, Range 14 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
