

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JANUARY 11, 2011**, upon the application of **HILCORP ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **5A Sand, Reservoir G**, in the West Bay Field, Plaquemines Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the 5A Sand, Reservoir G.
2. To create a single drilling and production unit for this sand and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate Hilcorp Energy Company as operator of the 5A RG SUA.
4. To designate the Hilcorp Energy Company-J.G. Timolat "B" No. 162 Well as the unit well for 5A RG SUA.
5. To provide that the 5A Sand, Reservoir G should be exempt from the spacing provisions of Statewide Order No. 29-E.
6. To provide that the Commissioner of Conservation may reclassify the reservoir by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted based on evidence furnished the Commissioner of Conservation.
7. To consider such other matters as may be pertinent.

The 5A Sand, Reservoir G is hereby defined as being that gas and condensate bearing sand encountered between the depths of 7,716' and 7,790' electrical log measured depths (7,110' to 7,147' tvd) in the Hilcorp Energy Company-J.G. Timolat "B" No. 162 Well, located in Section 25, Township 22 South, Range 30 East.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
