Dear Sir:

On behalf of XTO ENERGY, INC., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Wilcox F1 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana:

1. To permit the applicant to designate and utilize the XTO Energy, Inc. - LA Cent O & G No. E-180 Alt. as an alternate unit well for WX F1 RA SU478, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 1235-B, effective January 1, 1986.
2. To explicitly find that the proposed alternate unit well is reasonable and in the interest of conservation, and is necessary to drain a portion of the Wilcox F1 Zone, Reservoir A, in the Olla Field, underlying WX F1 RA SU478, which cannot be efficiently and economically drained by any existing well in such unit.
3. To provide that the unit allowable for WX F1 RA SU478 may be produced from either the unit well, the alternate unit wells, or any combination thereof, at the operator's discretion.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Wilcox F1 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana, was defined in Office of Conservation Order No. 1235-B-8, effective October 7, 1987.

The Revised Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

A copy of any such pertinent data can be obtained AT THE EXPENSE OF THE REQUESTING PARTY.

A list of the names and addresses of all Interested Owners, Represented Parties and Interested Parties (as defined in the Revised Rules of Procedure) is attached hereto. A copy of this notice, with the annexed plat, is being sent to each of such persons. A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Revised Rules of Procedure. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.



Your receipt of this Hearing Application does not require you to take any action. It is meant to notify you of these proceedings so that you have the opportunity to participate if you so desire.

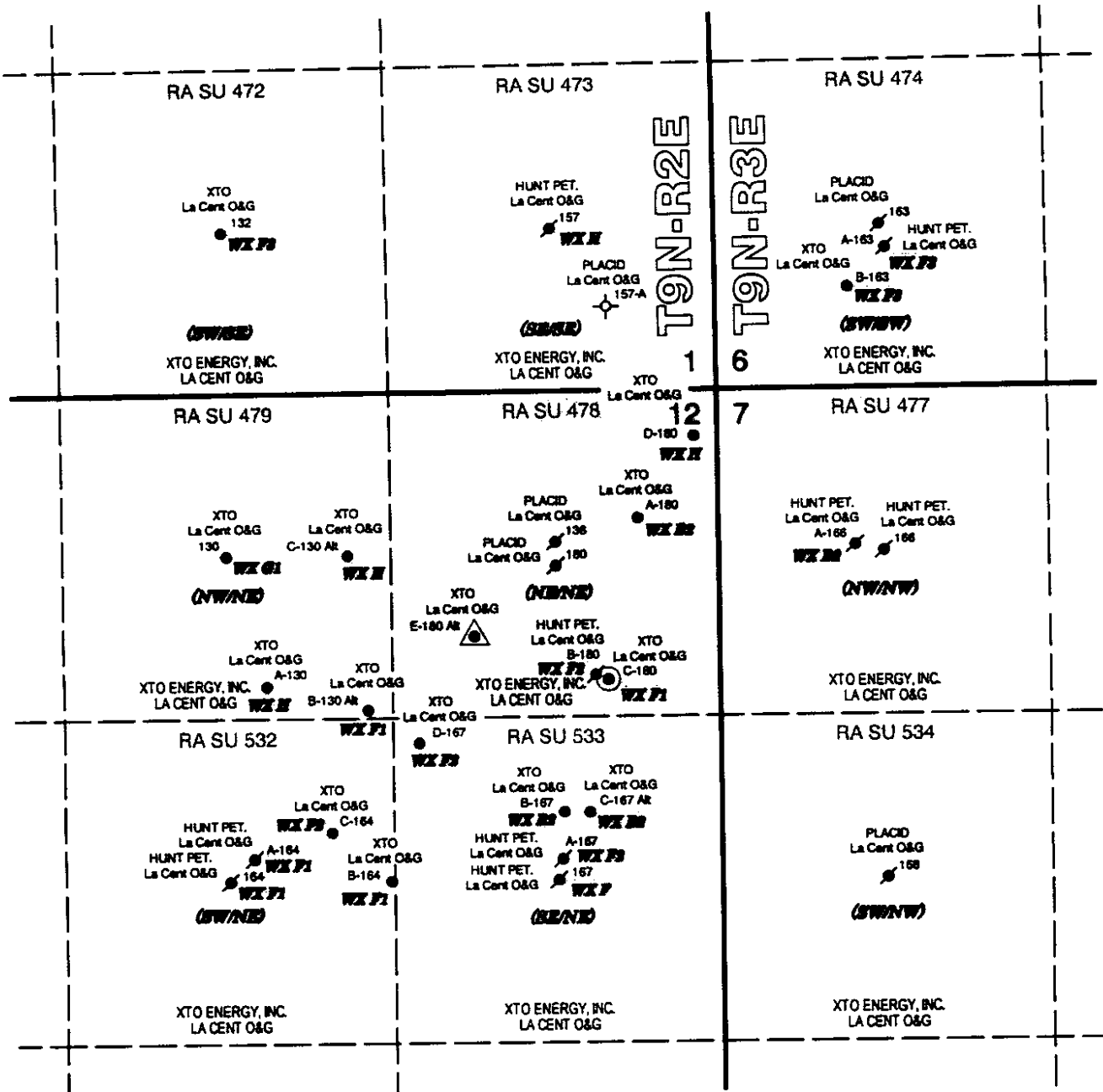

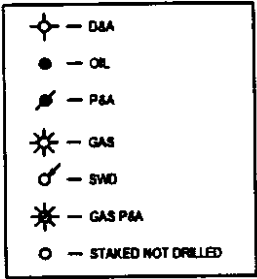
