Dear Commissioner Welch,

Application is hereby made on behalf of ZACHRY EXPLORATION, LLC to the Commissioner of Conservation for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of orders pertaining to the following matters relating to the Tweedel Zone, Reservoir B, in the Richie Field, Acadia Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Tweedel Zone, Reservoir B, in the Richie Field, Acadia Parish, Louisiana, said unit to be designated TW RB SUA, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate a unit operator and a unit well for the unit so created.
4. To provide that any wells drilled to the Tweedel Zone, Reservoir B shall be located in accordance with the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner may reclassify the reservoirs by Supplemental Orders without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished by the Commissioner.

6. To discuss any other matters that may be pertinent to this application.

The Tweedel Zone, Reservoir B, in the Richie Field is hereby defined as that gas and condensate bearing sand encountered between the depths of 9530' - 9642' electric log measured depths in the Bates & Cornell; Maccabees et al B-1 well, located in Section 20, Township 7 South, Range 1 West, Acadia Parish, Louisiana.

In compliance with the Rules of Procedure, a pre-application notice was given, but no request for a conference was received, and therefore, none was held. No opposition is expected at the hearing.

All pertinent data relating to the subject application can be obtained **AT THE COST OF THE REQUESTING PARTY**, from David Sturlese, P. O. Box 51405, Lafayette, LA 70505, (337) 232-1700.

There are attached hereto and made a part hereof, plats outlining the proposed unit.
