On behalf of PETRO-HUNT, L.L.C., application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Wilcox B1 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana:

1. To permit the applicant to designate and utilize the Petro-Hunt, L.L.C. - Tremont H No. B-18 as an alternate unit well for WX B1 RA SU322, at the location shown on the plat attached hereto, in exception to the well spacing provisions of Office of Conservation Order No. 1235-B, effective January 1, 1986.
2. To explicitly find that the proposed alternate unit well is reasonable and in the interest of conservation, and is necessary to drain a portion of the Wilcox B1 Zone, Reservoir A, in the Olla Field, underlying WX B1 RA SU322, which cannot be efficiently and economically drained by any existing well in such unit.
3. To provide that the unit allowable for WX B1 RA SU322 may be produced from either the unit well, the alternate unit wells, or any combination thereof, at the operator's discretion.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Wilcox B1 Zone, Reservoir A, in the Olla Field, LaSalle Parish, Louisiana, was defined in Office of Conservation Order No. 1235-B-8, effective October 7, 1987.

The Revised Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

A copy of this notice, with the annexed plat, is being sent to each of such persons. A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Revised Rules of Procedure. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Shreveport District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.


This application is being filed in duplicate, and a copy hereof is being sent to Mr. Joseph Devall, Monroe District Manager of the Office of Conservation and to each Interested Owner, Represented Party and Interested Party whose name is shown on the attached list.

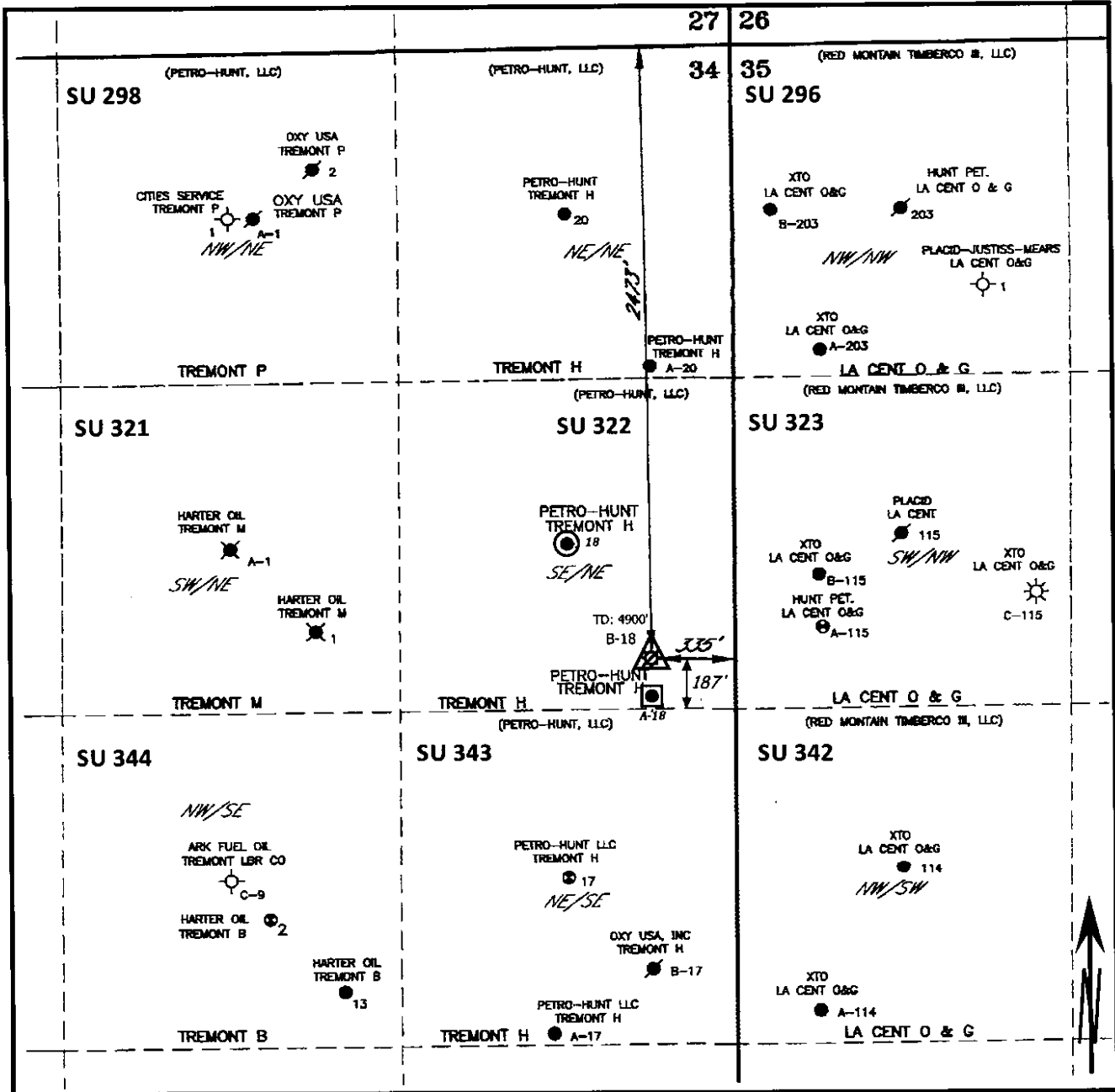

-  Proposed WX B1 RA Alternate Unit Well at Exceptional Location


