- 3. To recommend at the hearing the creation of a single revised reservoirwide unit for the G6b Sand.
- 4. To force pool and unitize all separately owned tracts, mineral leases and other property interests within the proposed reservoirwide unit for the sand, with each tract sharing in the unit production on a surface acre basis of participation.
- 5. To confirm Milagro Exploration, LLC as unit operator for the revised reservoirwide unit so created.
- 6. To consider such other matters as may be pertinent.

The G6b Sand, Reservoir A, SU was defined in Order No. 50-JJJ, effective January 10, 1989.
