Dear Mr. Commissioner:

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, application is hereby made on behalf of **Swift Energy Operating, LLC** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 6750' Zone, Reservoir B, Lake Washington Field, Plaquemines Parish, Louisiana

1. To create a single drilling and production unit of approximately 20 acres for the 6750' Zone, Reservoir B designated as the 6750' RB SUA, Lake Washington Field, Plaquemines Parish, Louisiana, and to exempt the unit from the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E) all as shown more particularly on the attached plat.
2. To establish rules and regulations governing the exploration for and production of oil and gas from the said unit.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created, with each tract sharing in unit production on a surface acreage basis of participation.
4. To designate a unit operator and unit well for the unit created herein.
5. To consider such other matters relating to the subject reservoir as may be appropriate and justified by the evidence presented at the public hearing.

The 6750' Zone, Reservoir B in the Lake Washington Field, Plaquemines Parish, Louisiana is hereby defined as that oil and gas bearing zone encountered between the measured depths of 6,882 feet and 7,909 feet (electrical log measurements) (6,341' - 7,154' VD) in the Swift Energy Operating, LLC-Cockrell-Moran No. 292 Well (SN 231391), located in Section 34, Township 20 South, Range 26 East, Plaquemines Parish, Louisiana.

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, the Commissioner of Conservation, the District Manager of the Lafayette District of the Office of Conservation and all interested owners, represented parties and interested parties known to the applicant after a reasonable search were notified in writing in the pre-application notice dated October 29, 2010 that a conference to discuss the proposed application was tentatively scheduled for 2:00 p.m. on Thursday November 18, 2010. It was stated at that time that this conference would be held only if a request to confer were received by the undersigned within ten (10) calendar days after the date of the pre-application notice. No requests to confer were received either in writing or by telephone and, in accordance with the Rules of Procedure, the tentatively scheduled conference **WILL NOT BE HELD**.

Attached hereto and made a part hereof is a plat outlining the 6750' RB SUA, Lake Washington Field, Plaquemines Parish, Louisiana, and a list of the names and addresses of the interested owners, represented parties and interested parties to whom this notice is being sent. It is hereby certified that a reasonable effort was made to ascertain the names and addresses of all interested owners, represented parties and interested parties.

A copy of the list of the names and addresses of the interested owners, represented parties and interested parties is not being mailed to those parties along with this application. Should any such party desire a copy of this list, however, we will be glad to provide one upon request.

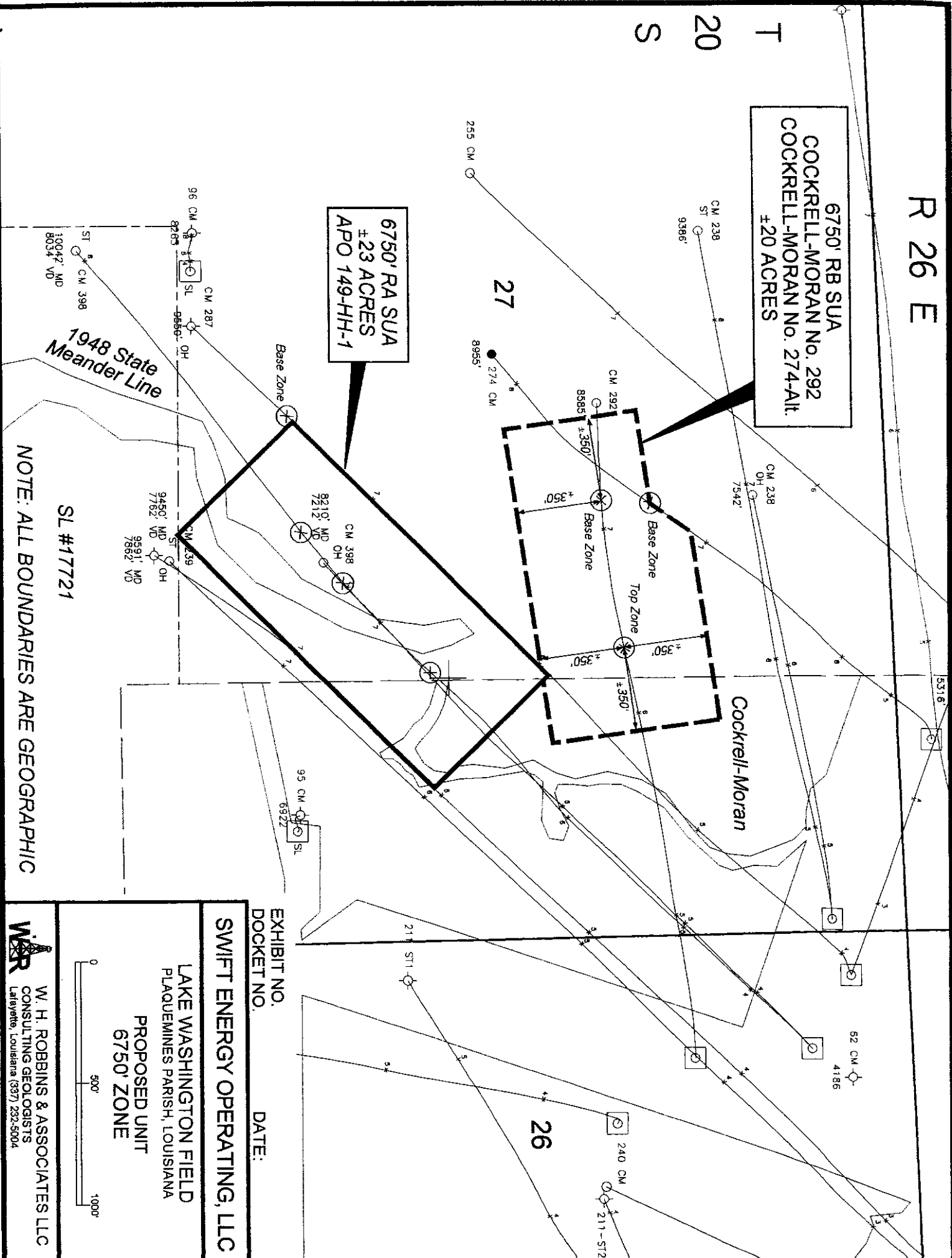

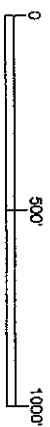
