On behalf of Tensas Delta Exploration Company, LLC, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Cedar Grove Field, Caddo Parish, Louisiana:

- To create one (1) additional drilling and production unit (to be designated as HA RA 1. SUW) for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A, in the Cedar Grove Field, Caddo Parish, Louisiana, as shown on the plat attached hereto.
- To force pool and unitize all separately owned tracts, mineral leases, and other 2. property interests within the proposed unit, with allocation of unit production to the tracts within said unit to be on the basis of surface acreage.
- To redefine the Haynesville Zone, Reservoir A, in the Cedar Grove Field, INSOFAR 3. AND ONLY INSOFAR as the proposed HA RA SUW, is concerned, as being the stratigraphic equivalent of that gas and condensate bearing interval between the depths of 9,960 feet and 11,542 feet (electrical log measurements) in the Petrohawk Operating Company - B & K Exploration 37 No. 1 Well (Serial No. 238527) located in Irregular Section 37, Township 17 North, Range 13 West, Caddo Parish, Louisiana.
- 4. With respect to future horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve HA RA SUW, where the horizontal portion of the well is cased and

cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus;

- 5. Except to the extent contrary herewith, to extend the provisions of Office of Conservation Order No. 967-C, effective August 12, 2008, as amended and supplemented by the 967-C Series of Orders, to HA RA SUW.
- 6. To consider such other matters and issue such orders as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Cedar Grove Field, Caddo Parish, Louisiana was defined in Office of Conservation Order No. 967-C, effective August 12, 2008, but shall be redefined as set forth above.
