**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **WEDNESDAY, JANUARY 19, 2011**, upon the application of **ZACHRY EXPLORATION, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **4300' Zone, Reservoir A**, in the South Bayou Mallet Field, Acadia Parish, Louisiana.

1. To permit applicant, Zachry Exploration, LLC to drill, designate and utilize the B&Q Properties No. 1 as a second alternate unit well for the 4300' Zone, Reservoir A, SUA, such well to be at the location shown on the plat submitted with the application.
2. To make a specific finding that such proposed alternate unit well is necessary to effectively and efficiently drain a portion of the 4300 RA SUA which cannot be efficiently and economically drained by any other well within the unit.
3. To grant a single unit allowable for 4300 RA SUA and to permit the operator of the unit to produce said unit allowable from the unit well, the alternate unit wells, or from any combination at its option.
4. To confirm Zachry Exploration, LLC as the operator of the 4300 RA SUA.
5. To find that, except to the extent contrary in the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation Order No. 271-V shall remain in full force and effect.
6. To consider such other matters as may be pertinent.

The 4300' Zone, Reservoir A was previously defined in Order No. 271-V, effective May 4, 2010.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
