

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MARCH 1, 2011**, upon the application of **COMSTOCK OIL & GAS-LOUISIANA, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Converse Field, Sabine Parish, Louisiana.

1. To create one (1) drilling and production unit for the exploration for and production of gas and condensate from the Haynesville Zone, Reservoir A.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit, with allocation of production to the tracts within said unit to be on the basis of surface acreage participation.
3. To provide that with respect to future horizontal wells drilled to the Haynesville Zone, Reservoir A, within or to serve HA RA SU113, where the horizontal portion of the well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) will be calculated based on the distance to the nearest perforation in the well, and not based on the penetration point or terminus.
4. Except to the extent contrary herewith, to provide that the provisions of the Office of Conservation Order No. 501-G, effective April 7, 2009, as amended and supplemented by the 501-G Series of Orders, shall remain in full force and effect.
5. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was defined in Order No. 501-G, effective April 7, 2009.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
