Dear Commissioner Welsh:

Application is hereby made on behalf of **ENCANA OIL & GAS (USA), INC.** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

1. To permit the applicant to drill, designate and utilize seven (7) cross unit horizontal alternate unit wells for HA RA SU57 and HA RA SU64 and fourteen (14) cross unit horizontal alternate unit wells for HA RA SU55, at the locations shown on the plat attached hereto and made a part hereof, in exception to the spacing provisions of Office of Conservation Order No. 990-D, effective July 15, 2008.
2. To permit the operator to produce the unit allowable from the unit well and the proposed horizontal alternate unit wells in any combination at its discretion.
3. To find that these wells are necessary to efficiently and economically drain a portion of the reservoir covered by each unit that cannot be so drained by any existing well within such unit.
4. To find that unit production from each cross unit horizontal alternate unit well shall be allocated to each unit in the same proportion as the perforated length of the lateral in each unit bears to the total length of the perforated lateral as determined by an "as drilled" survey performed after the cross-unit well is drilled and completed.

5. Except insofar as set forth above, to confirm and continue in effect the provisions of Office of Conservation Order No. 990-D, effective July 15, 2008, as amended and supplemented by the 990-D Series of Orders, the units created thereby and applicable Statewide Orders.
6. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A, in the Woodardville Field, Red River Parish, Louisiana, was defined in Office of Conservation Order No. 990-D, effective July 15, 2008.

Any pertinent data, including well logs, not available from the Office of Conservation, may be obtained, AT THE COST OF THE REQUESTING PARTY, from Bill Dale, W. H. Robbins & Associates LLC, 302 LaRue France, Lafayette, Louisiana, Telephone No. (337) 232-5004.


Note that the proposed cross unit laterals will be perforated no closer than 330 feet from any boundary of a unit other than those for which they are designated to serve as alternate unit wells.

Attached hereto and made a part hereof is a plat, along with a list of the names and addresses of the Interested Owners, Represented Parties, and Interested Parties, to whom a copy of this application is being mailed. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and the District Manager of the Shreveport District of the Office of Conservation; however, the list of parties will be furnished to any party requesting a copy. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, enclosed is our check on behalf of the applicant, in the amount of \$2,265.00, **made payable to the Office of Conservation**, representing the required hearing application fee.

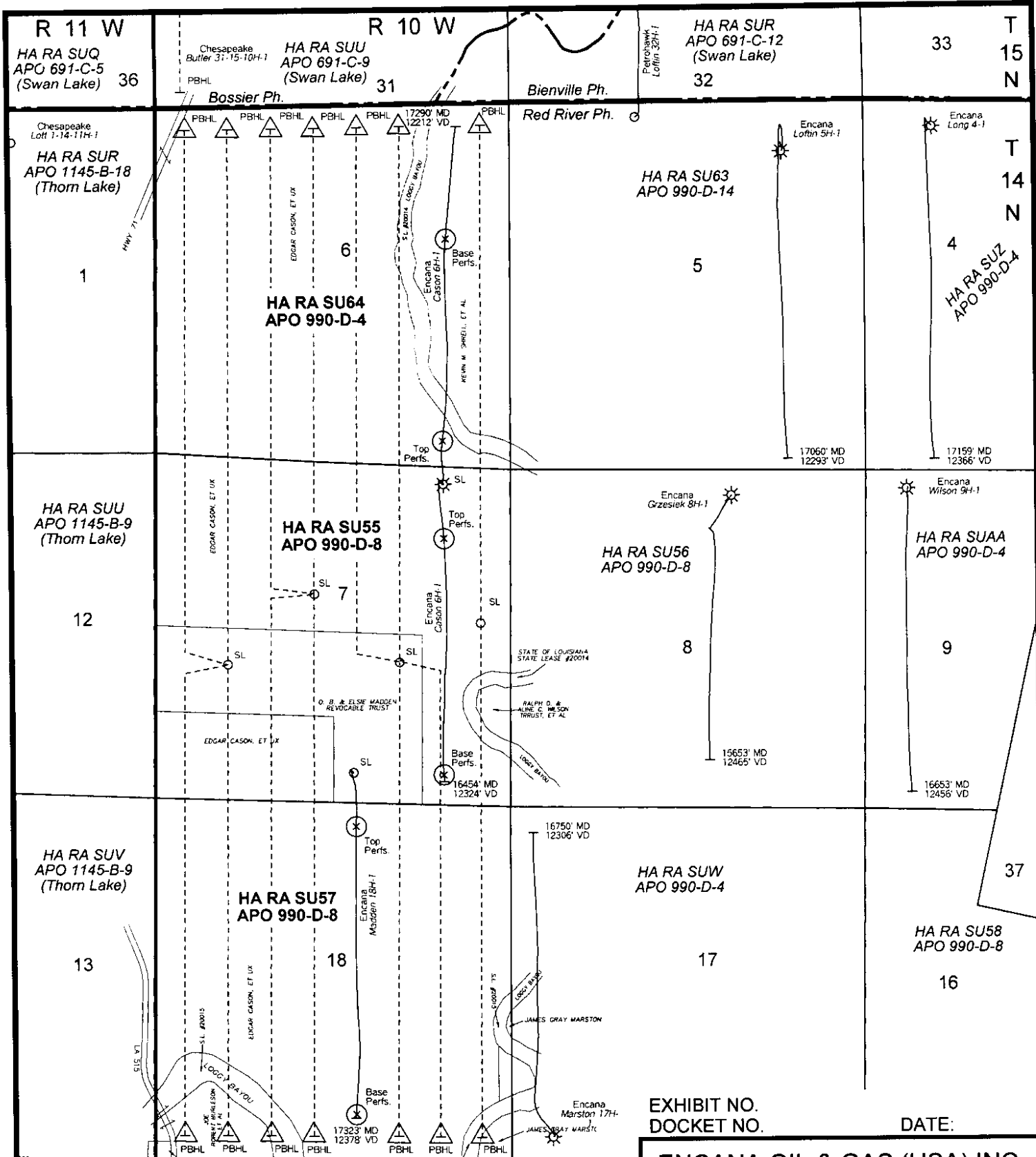
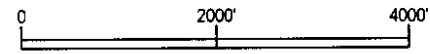
