In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on TUESDAY, FEBRUARY 22, 2011, upon the application of EL PASO E&P COMPANY, LP.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Logansport Field, DeSoto Parish, Louisiana.

- 1. To authorize Applicant to drill, designate and utilize five (5) horizontal wells as alternate unit wells for the unit designated HA RA SU57 and two (2) horizontal wells as alternate unit wells on each of the units designated HA RA SUI and HA RA SUJ, at the locations shown on the plats submitted with the application.
- 2. To provide that where the horizontal portion of a well is cased and cemented back above the top of the Haynesville Zone, Reservoir A, the distance to any unit boundary and any offset well(s) shall be calculated based on the distance to the nearest perforation in the well and not based on the penetration point or terminus.
- 3. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir A, underlying the unit on which it is located which cannot be efficiently and economically drained by any existing well on such unit.
- 4. To permit the operator of HA RA SU57, HA RA SUI and HA RA SUJ to produce the allowables assigned to these units from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the Operator.
- 5. Except insofar as set forth above, to confirm and continue in effect the provisions of Office of Conservation Order No. 28-AA, effective July 29, 2008, as amended and supplemented by the 28-AA Series of Orders, the units created thereby and applicable Statewide Orders.
- 6. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was defined in Order No. 28-AA, effective July 29, 2008.
