

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, FEBRUARY 22, 2011**, upon the application of **EL PASO E&P COMPANY, LP.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir A**, in the Kingston Field, DeSoto Parish, Louisiana.

1. To authorize Applicant to drill, designate and utilize two (2) horizontal wells as additional alternate unit wells for HA RA SUI, two (2) horizontal wells as additional alternate unit wells for HA RA SUJ, two (2) horizontal wells as additional alternate unit wells for HA RA SUN, two (2) horizontal wells as additional alternate unit wells for HA RA SUP and two (2) horizontal wells as additional alternate unit wells for HA RA SUQ, all at the locations shown on the plats submitted with the application.
2. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir A, underlying the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
3. To permit the operator of HA RA SUI, HA RA SUJ, HA RA SUN, HA RA SUP and HA RA SUQ to produce the allowables assigned to these units from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the Operator.
4. To provide that with respect to these proposed alternate unit wells, where the horizontal portion of a well is cased and cemented back above the top of the Haynesville Zone, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforation in the well and not on the penetration point or terminus.
5. Except insofar as set forth above, to confirm and continue in effect the provisions of Office of Conservation Order No. 376-D, effective November 18, 2008, as amended and supplemented by the 376-D Series of Orders, the units created thereby and applicable Statewide Orders.
6. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir A was defined in Order No. 376-D, effective November 18, 2008.

Plats are available for inspection in the Office of Conservation in **Baton Rouge** and **Shreveport**, Louisiana.
