

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, FEBRUARY 15, 2011**, upon the application of **CLOVELLY OIL CO., LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Frio Zone, Reservoir D**, in the Pine Prairie Field, Evangeline Parish, Louisiana.

1. To establish rules and regulations and to create three (3) drilling and production units for the exploration for and production of oil and gas from the Frio Zone, Reservoir D.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units with each tract sharing in unit production on a surface acreage basis of participation.
3. To provide that any wells drilled to the Frio Zone, Reservoir D, should be located no closer than 100 feet from unit boundaries in exception to the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
4. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by Supplemental Order without the necessity of a public hearing should the producing characteristics of such reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such other matters as may be pertinent.

The Frio Zone, Reservoir D is hereby defined as being that oil and gas bearing zone encountered between the depths of 4,163' and 7,705' in the Clovelly Oil Co. LLC-Ledanois Land & Stone No. 4 Well, located in Section 35, Township 3 South, Range 1 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
