In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on TUESDAY, FEBRUARY 15, 2011, upon the application of HELIS OIL & GAS COMPANY, LLC.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the S Sand, Reservoir A and 9,200's Sand, Reservoirs A, B and C, in the West Black Bay Field, Plaquemines Parish, Louisiana.

- 1. To amend the spacing provisions of Office of Conservation Order No. 437-A, effective October 1, 1958, as amended and supplemented by the 437-A Series of Orders, to eliminate any special spacing or well density provisions within or outside the buffer zone for production from the S Sand and to provide that any future wells drilled within or outside the buffer zone or within or outside existing units for the S Sand be exempt from the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
- 2. To amend the spacing provisions of Order No. 437-B, effective October 1, 1958, as amended and supplemented by the 437-B Series of Orders, to eliminate any special spacing or well density provisions within or outside the buffer zone for production from the 9,200' Sand, and to provide that any future wells drilled within or outside the buffer zone or within or outside existing units for the 9,200' Sand be exempt from the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
- 3. Except to the extent herein contrary, to confirm and continue in effect all other pertinent provisions of the above referenced orders, the units created thereby and applicable Statewide Orders.
- 4. To consider such other matters as may be pertinent.

The S Sand was defined in Order No. 437-A, effective October 1, 1958.

The 9,200' Sand was previously defined in the 437-B Series of Orders.
