

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, FEBRUARY 22, 2011**, upon the application of **HILCORP ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **MA-11 Zone, Reservoir B**, in the Garden City Field, St. Mary Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the MA-11 Zone, Reservoir B.
2. To create a single drilling and production unit for the MA-11 Zone, Reservoir B and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate Hilcorp Energy Company as operator of the MA-11 RB SUA.
4. To designate the Hilcorp Energy Company-Shinn No. 9 Well as the unit well for MA-11 RB SUA.
5. To provide that the MA-11 Zone, Reservoir B, should be exempt from the spacing provisions of Statewide Order No. 29-E.
6. To provide that the Commissioner of Conservation may reclassify the reservoir by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
7. To consider such other matters as may be pertinent.

The MA-11 Zone, Reservoir B is hereby defined as being that gas and condensate bearing zone encountered between the depths of 16,310' and 16,552' (electrical log measurements) in the Hilcorp Energy Company (formerly Quintana)-Shinn No. 9 Well, located in Section 30, Township 15 South, Range 10 East.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
