EL PASO E&P COMPANY, L.P. ("Applicant"), hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Haynesville Zone, Reservoir A, in the Holly Field, DeSoto Parish, Louisiana:

1. To authorize Applicant to designate and utilize its Franklin 10H No. 1-Alt. Well as an alternate unit well for HA RA SUM, said well being located as shown on the attached plat, in exception to the spacing provisions of Office of Conservation Order No. 88-J, effective July 29, 2008.

2. To explicitly find that designation and use of the Franklin 10H No. 1-Alt. Well as an alternate unit well for HA RA SUM is in the interest of conservation, will prevent waste and the drilling of an unnecessary well, and is necessary to drain a portion of the Haynesville Zone, Reservoir A, underlying HA RA SUM which cannot be efficiently and economically drained by any existing well on such unit.

3. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Haynesville Zone, Reservoir A, in the Holly Field, DeSoto Parish, Louisiana, was defined in Office of Conservation Order No. 88-J, effective July 29, 2008.

Any pertinent data concerning this application will be available for inspection at the offices of Louis Gilbert & Associates, Inc., 3636 N. Causeway Blvd., Suite 204, Metairie, Louisiana 70002-7216. 
As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.
