

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, FEBRUARY 22, 2011**, upon the application of **MACK ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **L-P Zone, Reservoir A and U-Y Zone, Reservoir A**, in the Good Hope Field, St. Charles Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of oil and gas from the L-P Zone, Reservoir A and U-Y Zone, Reservoir A.
2. To create a single drilling and production unit for each zone and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
3. To designate a unit operator and a unit well for the units so created as may be appropriate.
4. To provide that any well drilled outside of the L-P Zone, Reservoir A and U-Y Zone, Reservoir A, shall be in accordance with the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner of Conservation may reclassify the reservoirs by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
6. To consider such other matters as may be pertinent.

The L-P Zone is hereby defined as being that oil and gas bearing zone encountered between the depths of 7,145' to 7,835' (electrical log measurements) in the Shell Oil Co.-R&RT No. 23 Well, located in Section 7, Township 12 South, Range 8 East.

The U-Y Zone is hereby defined as being that oil and gas bearing zone encountered between the depths of 8,748' to 9,300' (electrical log measurements) in the Shell Oil Co.-R&RT No. 35 Well, located in Section 7, Township 12 South, Range 8 East.

Plats are available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
