Dear Sir:

Application is hereby made on behalf of Sunnyside Resources, Inc., for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the 19,100' Tuscaloosa Zone, Reservoir B, in the Profit Island Field, East Baton Rouge Parish.

1. To establish rules and regulations governing the exploration for and production of gas and condensate.

2. To create a single drilling and production unit and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created in accordance with Section 10, Title 30 of the Louisiana Revised Statutes of 1950, with each separate tract sharing in unit production on a surface acreage basis of participation.

3. To provide that future wells drilled to the 19,100' Tuscaloosa Zone, Reservoir B, within or outside of the proposed unit shall be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).

4. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.

5. To consider such other matters as may be pertinent.

The 19,100' Tuscaloosa Zone, Reservoir B, in the Profit Island Field, East Baton Rouge Parish, Louisiana, is hereby defined as that gas and condensate bearing zone encountered between the depths of 18,330' to 20,500' (electrical log measurements) in Amoco Production Company (Chevron USA Inc.)-Hurst-Richard et al No. 1 Well; (WSN 167534), located in Section 49, Township 5S, Range 11E, Pointe Coupee Parish, Louisiana.

Pursuant to the Rules of Procedure, pre-application notice was given; however, no request for the conference was received. Therefore, the conference tentatively scheduled for Friday, January 28, 2011, WILL NOT BE HELD.

All pertinent data that is not otherwise available from the Office of Conservation can be obtained at the expense of the requesting party from the undersigned.

There is enclosed herewith and made a part hereof a list of names and addresses of the Interested Parties, Interested Owners and Represented Parties to whom this notice is being sent. Pursuant to the Revised Rules of Procedure, such list of Parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Lafayette District of the Office of Conservation. The aforementioned list is available upon request to any Interested Party. A reasonable effort was made to ascertain the names and addresses of all Interested Parties, Interested Owners and Represented Parties as required by the Revised Rules of Procedure.

There is not a plat attached to this application as there have been no alterations or changes made to the plat attached to the pre-application notice.

Enclosed is a check in the amount of \$755.00 made payable to the Office of Conservation submitted on behalf of the applicant representing the hearing application fee.
