NOTICE TO THE COMMISSIONER OF CONSERVATION AND OTHERS:

RE: Cockfield – Sparta Zone, Reservoir A
LAWTELL FIELD
St. Landry Parish, Louisiana

Application is hereby made on behalf of Brammer Engineering Inc. for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an Order relating to the above captioned sand and reservoir, in the Lawtell Field, St. Landry Parish, Louisiana. A Pre-Application Notice was previously filed by Brammer Engineering Inc. The proposed order and hearing will address the following matters:

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Cockfield – Sparta Zone, Reservoir A, in the Lawtell Field, St. Landry Parish, Louisiana as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created with each tract sharing in production on a surface acre basis.
3. To provide that any future wells drilled to the Cockfield – Sparta Zone, Reservoir A, within or outside of the proposed unit created herein, should be located in accordance with the spacing provisions of LAC 43:XIX.1909 et seq. (Statewide Order 29-E).
3. To provide that the Commissioner of Conservation may reclassify Cockfield – Sparta Zone, Reservoir A by supplemental order without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished to the Commissioner of Conservation.
5. To consider any other matters that may be pertinent to this application.

The Cockfield-Sparta Zone, Reservoir A, is defined as that gas and condensate bearing zone between the depths of 10760' and 12,930' measured depth in the Sevarg (Enron Oil and Gas Co.) Beverly No. 1 well (SN 208168), located in Section 97, Township 6 South, Range 4 East, St. Landry Parish, Louisiana.

The Cockfield-Sparta Zone RA has not been proven productive in the Lawtell Field. A waiver of the test in the field is required in connection with the unitization of the above mentioned reservoir in accordance with the Office of Conservation Policy Memorandum dated March 16, 1998. The waiver for the Cockfield-Sparta Zone RA in the Lawtell Field was granted by the Office of Conservation on January 10, 2011.



This list includes the names and addresses of all Interested Parties who are known to the applicant, after reasonable search. A reasonable effort was made to ascertain the names and addresses of all Interested Owners, Represented Parties and Interested Parties.

Finally, there is attached hereto a check made out to the Louisiana Office of Conservation in the amount of \$755.00 representing the application fee for this application.
