At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the E-1 Sand, Reservoir B and E-4 Sand, Reservoir A, in the Lake Barre Field, Terrebonne Parish, Louisiana.

- 1. To establish rules and regulations governing the exploration for and production of oil and gas from the E-1 Sand, Reservoir B and E-4 Sand, Reservoir A.
- 2. To create a single drilling and production unit for each of these sands and to force pool and integrate all separately owned tracts, mineral leases and other property interests within the units so created.
- 3. To designate Hilcorp Energy Company as operator of the E-1 RB SUA and E-4 RA SUA.
- 4. To designate Hilcorp's Lake Barre Unit 32 No. 30 Well as the unit well for the E-1 RB SUA and E-4 RA SUA.
- 5. To provide that the E-1 Sand, Reservoir B and E-4 Sand, Reservoir A should be exempt from the spacing provisions of Statewide Order No. 29-E.
- 6. To provide that the Commissioner of Conservation may reclassify the Reservoirs by Supplemental Orders and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
- 7. To consider such other matters as may be pertinent.

The E-1 Sand, Reservoir B is hereby defined as being that oil and gas bearing sand encountered between the depths of 10,603' to 10,632' electric log measured depths (10,591' to 10,619' tvd) in the Hilcorp Energy Company-Lake Barre Unit 33 No. 21 Well, located in Township 21 South, Range 20 East.

The E-4 Sand, Reservoir A is hereby defined as being that oil and gas bearing sand encountered between the depths of 10,908' to 10,968' electric log measured depths (10,892' to 10,951' tvd) in the Hilcorp Energy Company-Lake Barre Unit 33 No. 21 Well, located in Township 21 South, Range 20 East.
