LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MARCH 29, 2011**, upon the application of **J-W OPERATING COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Haynesville Zone, Reservoir B**, in the Red River Bull Bayou Field, DeSoto and Red River Parishes, Louisiana.

1. To authorize Applicant to drill, designate and utilize three (3) horizontal wells as alternate unit wells on the unit designated HA RB SU71 and two (2) horizontal wells as alternate unit wells on each of the units designated HA RB SU72 and HA RB SU73, all as shown on the plat submitted with the application.
2. To find that each of the proposed alternate unit wells is necessary to efficiently and economically drain a portion of the Haynesville Zone, Reservoir B, underlying the unit on which it is proposed to be drilled which cannot be efficiently and economically drained by any existing well on such unit.
3. To permit the operator of each of these units to produce the allowable assigned to a unit from either the unit well, from any alternate unit well, or from any combination of such wells, at the option of the operator.
4. To provide that with respect to these proposed alternate unit wells, where the horizontal portion of a well is cased and cemented back above the top of the Haynesville Zone, Reservoir B, the distance to any unit boundary and any offset well(s) should be calculated based on the distance to the nearest perforation in the well and not based on the penetration point or terminus.
5. Except as in conflict with these proposals, to confirm and continue in effect the provisions of Office of Conservation Order No. 109-X-4, effective November 6, 2008, as amended and supplemented by the 109-X Series of Orders, the units created thereby and of all applicable Statewide Orders.
6. To consider such other matters as may be pertinent.

The Haynesville Zone, Reservoir B was defined in Order No. 109-X-4, effective November 6, 2008.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Shreveport**, Louisiana.
