

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 5, 2011**, upon the application of **GULF SOUTH OPERATORS, INC.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Exposito C Zone, Reservoir C**, in the Lapeyrouse Field, Terrebonne Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Exposito C Zone, Reservoir C.
2. To create a single drilling and production unit for the exploration for and production of gas and condensate from the Exposito C Zone, Reservoir C.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed units, with each tract sharing in unit production on a surface acreage basis of participation.
4. To designate the Gulf South Operators, Inc.-LL&E No. 1 Well (WSN 242191) as the unit well in exception to the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
5. To designate Gulf South Operators, Inc. as the unit operator.
6. To provide that any future wells drilled to the Exposito C Zone, Reservoir C, shall be exempt from the well spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
7. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by Supplemental Order without the necessity of a public hearing if the producing characteristics of the reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
8. To consider such other matters as may be pertinent.

The Exposito C Zone, Reservoir C is hereby defined as that gas and condensate bearing zone encountered between the depths of 13,704' and 14,040' in the Placid Oil Company-A.M. Dupont Corp. No. A-2 Well (WSN 51493), located in Section 15, Township 20 South, Range 18 East.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
