

LEGAL NOTICE

STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, APRIL 26, 2011**, upon the application of **MIDSTATES PETROLEUM CO., LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Frio Zone, Reservoir C**, in the Pine Prairie Field, Evangeline Parish, Louisiana.

1. To redefine the F RC SUA previously created by Office of Conservation Order No. 32-M-5, effective December 14, 2010.
2. To confirm the unit established by Order No. 32-M-5, effective December 14, 2010.
3. Except as may be in conflict with the provisions hereof, the provisions of Order No. 32-M-5 shall remain in full force and effect.
4. To consider such other matters as may be pertinent.

The Frio Zone, Reservoir C was previously defined in Order No. 32-M-5, effective December 14, 2010 and is hereby redefined as being that oil and gas bearing zone encountered between the measured depths of 5,066' (electrical log measurements) (4,913' vd) in the Midstates Petroleum Co., LLC-Crowell Land & Mineral Corp. 35 No. 3 Well (SN 241919) and 5,526' (electrical log measurements) (5,374' vd) in the Midstates Petroleum Co., LLC-Crowell Land & Mineral Corp. 35 No. 2 Well (SN 241291) all located in Section 35, Township 3 South, Range 1 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge and Lafayette**, Louisiana.
