In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1st Floor, LaSalle Building, 617 North 3rd Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY**, **APRIL 26**, **2011**, upon the application of **HILCORP ENERGY COMPANY**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Bol Mex B Sand, Reservoir A**, in the Perry Point Field, Acadia and Lafayette Parishes, Louisiana.

- 1. To dissolve the BOL M B RA SUA, as established by Office of Conservation Order No. 448-O, effective March 17, 1983, and simultaneously therewith, to create a revised unit for the exploration for and production of gas and condensate from the Bol Mex B Sand, Reservoir A.
- 2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created.
- 3. To designate Hilcorp Energy Company as operator of the BOL M B RA SUA.
- 4. To designate the Hilcorp Energy Company-Plattsmier Hulin No. 3 (ST) Well as the unit well for the BOL M B RA SUA.
- 5. To provide that the Bol Mex B Sand, Reservoir A, should be exempt from the spacing provisions of Statewide Order No. 29-E.
- 6. To provide that the Commissioner of Conservation may reclassify the Bol Mex B Sand, Reservoir A, by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
- 7. To consider such other matters as may be pertinent.

The Bol Mex B Sand, Reservoir A was fully defined in Order No. 448-O, effective March 17, 1983.

A plat is available for inspection in the Office of Conservation in Baton Rouge and Lafayette, Louisiana.
