

Dear Commissioner Welsh:

Application is hereby made on behalf of **HOUSTON ENERGY, LP** for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters:

1. To establish rules and regulations and to create a single drilling and production unit for the exploration for and production of gas and condensate from the Big Hum Zone, Reservoir C, in the Golden Meadow Field, Lafourche Parish, Louisiana, said unit to be designated BIG HUM RC SUA, as shown on the plat attached hereto and made a part hereof.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the proposed unit with each tract sharing in unit production on a surface acreage basis of participation.
3. To provide that any wells drilled to the reservoir, within or outside the unit created herein, should be located in accordance with the provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
4. To provide that the Commissioner of Conservation should be authorized to reclassify the reservoir by supplemental order without the necessity of a public hearing if the producing characteristics of the reservoir changes and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
5. To consider such others matters as may be pertinent.

The Big Hum Zone, Reservoir C, in Golden Meadow Field, is hereby defined as being the stratigraphic equivalent of that gas and condensate bearing zone encountered between the depths of 14,654 feet and 15,378 feet (electrical log measurements) (14,003 feet and 14,726 feet TVD) in the Apache Corporation – State Lease 19351 No. 1 Well (formerly LL&E Golden Meadow Well No. 238), with a surface location in Section 70 and a bottomhole location in Section 64 of Township 19 South, Range 21 East, Lafourche Parish, Louisiana.

Any pertinent data not available from the Office of Conservation, including well logs, may be obtained **AT THE COST OF THE REQUESTING PARTY** from Holmes Smart with Frank W. Harrison, Jr. and Associates, 200 Audubon Boulevard, Lafayette, Louisiana, 70503, Telephone Number (337) 298-2379.




