Applicant: Indian Exploration, Inc.

Dear Commissioner Welsh:

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation for the State of Louisiana, application is hereby made on behalf of Indian Exploration, Inc. for the calling of a public hearing, after legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters relating to the 6,620' Sand, Reservoir A in the Reddell Field, Evangeline Parish, Louisiana.

1. To create a single drilling and production unit of approximately 90 acres designated as the 6,620' RA SUA, Reddell Field, Evangeline Parish, Louisiana, all as shown more particularly on the attached plat;
2. To establish rules and regulations governing the exploration for and production of oil and gas from the said unit;
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created, with each tract sharing in unit production on a surface acreage basis of participation;
4. To designate a unit well and, an alternate unit well and unit operator for the proposed unit created herein.
5. To consider such other matters relating to the subject reservoir as may be appropriate and justified by the evidence presented at the public hearing.

The 6,620' Sand in Reddell Field, Evangeline Parish, Louisiana is hereby defined as that interval from 6,628' - 6,670' MD (6,545' - 6,587' SS) in the Indian Exploration, Inc.(Woods Petroleum Corp.) - Joseph M. Haas No. 1 well located in Section 22 Township 4 South, Range 1 West.

In accordance with the Rules of Procedure for Conducting Hearings Before the Commissioner of Conservation of the State of Louisiana, the Commissioner of Conservation, the District Manager of the Lafayette District of the Office of Conservation and all interested owners, represented parties and interested parties known to the applicant after a reasonable search were notified in writing in the pre-application notice date August 23, 2010. A conference was held on September 15, 2010 at the Petroleum Club, Lafayette, Louisiana to discuss the proposed application. Mr. Holmes Smart presented the Indian Exploration, Inc. plan. Questions were asked and answered. Mr. Travis Helms presented a plan for a landowner, Mr. Joe Haas which limited the size of the unit. As of this time, no resolution of the two plans has been made.


