At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the Sligo Formation, Reservoir A, in the Bear Creek Field, Bienville Parish, Louisiana.

- 1. To permit Applicant to designate and utilize its N. A. Culbertson 31 No. 1 Well as a substitute unit well for SLI RA SUD, said well being located as shown on the plat submitted with the application.
- 2. To find that designation and use of the N. A. Culbertson 31 No. 1 Well as a substitute unit well for SLI RA SUD is necessary to efficiently and economically drain a portion of the Sligo Formation, Reservoir A, underlying SLI RA SUD which cannot be efficiently and economically drained by an existing well within this unit.
- 3. To expand the provisions of Office of Conservation Order No. 78-75, effective December 12, 2006, which approved the downhole combination of production from the Hosston B Zone, Reservoir A, and a portion of the Hosston C Zone, Reservoir A, underlying the identical units HOSS B RA SUQ and HOSS C RA SUP, so as to include production from the Sligo Formation, Reservoir A, underlying SLI RA SUD, in any well in which the ownership interests in the units from which production is combined downhole are identical.
- 4. To consider such other matters as may be pertinent.

The Sligo Formation, Reservoir A was defined in Order No. 78-X, effective December 1, 1979.

A plat is available for inspection in the Office of Conservation in Baton Rouge and Shreveport, Louisiana.
