Application is hereby made on behalf of **Alta Mesa Services, LP** for the calling of a public hearing, after ten (10) days legal notice, to consider evidence relative to the issuance of an order pertaining to the following matters regarding the CM Sand, Reservoir A, SUO, Weeks Island Field, Iberia Parish, Louisiana.

1. To grant an exception to the spacing provisions of Office of Conservation Order No. 146-F, effective March 1, 1965 and to permit applicant to drill, utilize and designate the Alta Mesa Services, LP-R. H. Goodrich No. 25ST Well as a substitute unit well for the CM RA SUO;
2. To find that, except to the extent contrary to the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Office of Conservation No. 146-F, shall remain in full force and effect;
3. To confirm Alta Mesa Services, LP as operator of the CM RA SUO, and
3. To consider such other matters which may be pertinent to this application as shown by the evidence presented at the hearing held on this matter.

The CM Sand, Weeks Island Field, Iberia Parish, Louisiana was previously defined in Office of Conservation Order No. 146-F, effective March 1, 1965.

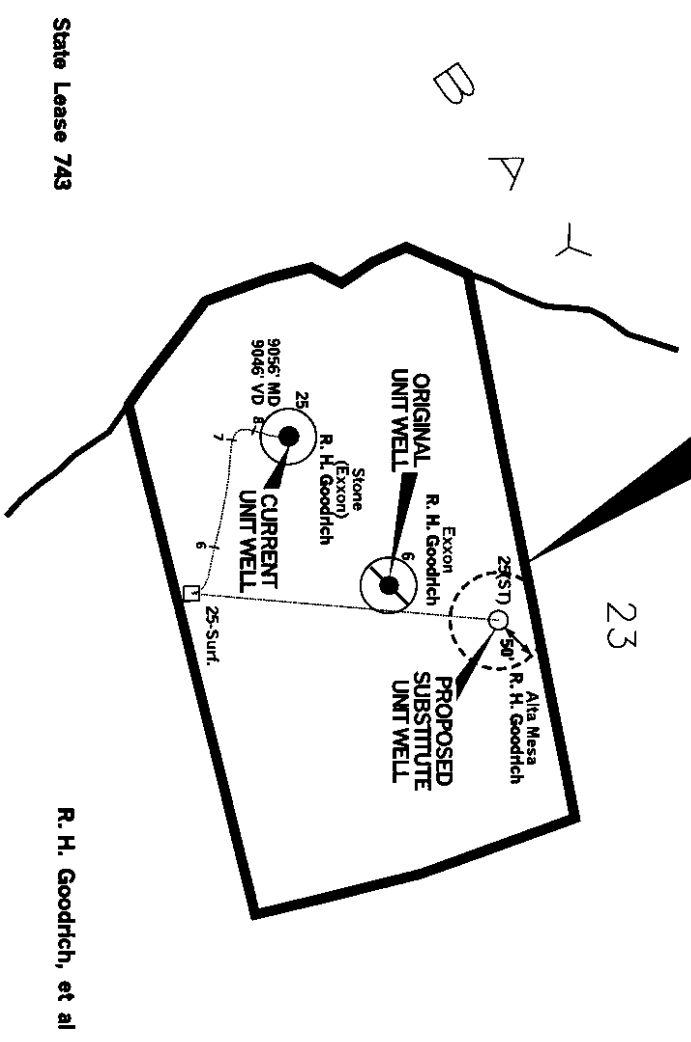
