**APPLICATION FOR PUBLIC HEARING**

Dear Sir:

Will-Drill Operating, LLC hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Cotton Valley Formation, Reservoir A, in the Caddo-Pine Island Field, Caddo Parish, Louisiana:

1. To establish one additional drilling and production unit for the Cotton Valley Formation, Reservoir A, in the Caddo-Pine Island Field, Caddo Parish, Louisiana, to be designated CV RA SUMM, as shown outlined on the plat attached hereto;
2. To redefine the Cotton Valley Formation, Reservoir A, INsofar AND ONLY INsofar as CV RA SUMM is concerned, as the stratigraphic equivalent of that oil and gas and/or gas and condensate bearing zone encountered between the depths of 6,972 feet and 8,390 feet (electrical log measurements) in the Texaco, Inc. - D L Gish, et al No. 1 Well located in Section 23, Township 20 North, Range 15 West, Caddo Parish, Louisiana;
3. To force pool and integrate all of the separately owned tracts, mineral leases and other property interests located within the proposed unit in accordance with Section 10, Title 30, of the Louisiana Revised Statutes of 1950, with each tract sharing in unit production on a surface acreage basis of participation;
4. To designate a unit well and unit operator, as appropriate;
5. To extend to the proposed unit the pertinent provisions of Office of Conservation Order No. 122-M, effective January 1, 1977, as amended and supplemented by the 122-M Series of Orders, and all applicable Statewide Orders, except to the extent inconsistent herewith; and

6. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Cotton Valley Formation, Reservoir A, in the Caddo-Pine Island Field, Caddo Parish, Louisiana, was defined in Office of Conservation Order No. 122-M, effective January 1, 1977, has been redefined for specific units by subsequent orders of the 122-M Series of Orders, and is to be redefined INsofar AND ONLY INsofar AS CV RA SUMM is concerned as provided herein.


