On behalf of COMSTOCK OIL & GAS-LOUISIANA, LLC, application is hereby made for a public hearing to receive evidence concerning the issuance of an order pertaining to the following matters relating to the Hosston D Zone, Reservoir A, in the Cheniery Creek Field, Ouachita Parish, Louisiana.

1. To permit the applicant to designate and utilize the Comstock Oil & Gas-Louisiana, LLC - Devon-Donner 3 No. 1 Well, as a substitute unit well for HOSS D RA SUC, at the location shown on the plat attached hereto, in exception to the spacing provisions of Office of Conservation Order No. 503-B-22, effective March 30, 1983.
2. To explicitly find that the proposed substitute unit well is reasonable and in the interest of conservation and is necessary to drain a portion of the Hosston D Zone, Reservoir A, in the Cheniery Creek Field underlying HOSS D RA SUC, which cannot be efficiently and economically drained by any existing well in such unit.
3. To provide that the unit allowable for HOSS D RA SUC may be produced from either the unit well, the substitute unit well, or any combination thereof, at the operator's discretion.
4. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Hosston D Zone, Reservoir A, in the Cheniery Creek Field, Ouachita Parish, Louisiana, was defined in the Office of Conservation Order No. 503, effective May 19, 1960.

The Revised Rules of Procedure of the Commissioner of Conservation pertaining to the Pre-Application Notice requirements, are not applicable to the hearing requested herein, which requires legal notice of only ten (10) days.

Pertinent data concerning the intended application will be made available for inspection at the offices of the undersigned. Any person wishing to inspect such data should call the undersigned at (318) 221-6858

during normal business hours or write the undersigned at the above address, in order to arrange a date and time for such inspection. A copy of any such pertinent data can be obtained AT THE EXPENSE OF THE REQUESTING PARTY.

A list of the names and addresses of all Interested Owners, Represented Parties and Interested Parties (as defined in the Revised Rules of Procedure) is attached hereto. A copy of this notice, with the annexed plat, is being sent to each of such persons. A reasonable effort has been made to determine that the enclosed list includes all of the persons to whom this notice must be sent under the Revised Rules of Procedure. Pursuant to the Revised Rules of Procedure, such list of parties is being furnished ONLY to the Commissioner of Conservation and to the District Manager of the Monroe District of the Office of Conservation. However, the list of parties will be provided to any party requesting a copy of it.

A check in the amount of \$755.00 made payable to the Commissioner of Conservation is enclosed herewith as the statutory fee for holding the requested hearing.



*Your receipt of this Hearing Application does not require you to take any action. It is meant to notify you of these proceedings so that you have the opportunity to participate if you so desire.*


