WildHorse Resources, LLC hereby makes application pursuant to the revised rules of procedure for a public hearing to consider evidence relating to the following matters pertaining to the Hall Sand and the Burgess-Simmons Sand in the Lisbon Field, Claiborne Parish, Louisiana:

- 1. To authorize Wildhorse Resources, LLC to drill, designate and utilize the W. W. Bennett 23 No. 1 Well as a substitute unit well for HALL SUI at the exceptional location shown on the plat attached hereto and made a part hereof;
- 2. To authorize Wildhorse Resources, LLC to drill, designate and utilize the B. W. White 23 No. 1 Well as an alternate unit well for HALL SUI at the exceptional location shown on the plat attached hereto and made a part hereof;
- 3. To establish that the proposed substitute unit well and alternate unit well on HALL SUI are necessary to efficiently and economically drain a portion of the Hall Sand underlying HALL SUI;
- 4. To authorize the unit allowable for HALL SUI to be recovered from the proposed substitute unit well, the proposed alternate unit well, or any combination thereof, at the discretion of the operator; and

- 5. To authorize Wildhorse Resources, LLC to drill, designate and utilize the F. M. Lowery 23 No. 1 Well (Serial No. 242902) as an alternate unit well for HALL SUK at the exceptional location shown on the plat attached hereto and made a part hereof;
- 6. To designate WildHorse Resources, LLC as operator of the proposed alternate unit well for HALL SUK, the F. M. Lowery 23 No. 1 Well, and to authorize WildHorse Resouces, LLC to report production from said well to the Office of Conservation separately from the unit well;
- 7. To find that the Vernon E. Faulconer, Inc. C. E. Patton, et al No. 1 Well (Serial No. 93359) should continue as the unit well for HALL SUK, that Vernon E. Faulconer, Inc. should remain as operator of said well, and that it be authorized to report production from said well to the Office of Conservation separately from the proposed alternate unit well;
- 8. To assign a single unit allowable to HALL SUK that may be recovered from the unit well, the proposed alternate unit well, or from a combination of such wells, with the allocation of such allowable between said wells to be arranged between the operators of the respective wells, in their discretion;
- To authorize the downhole or wellbore combination of hydrocarbons from any current or future well drilled on BS SUI and HALL SUI, or BS SUK and HALL SUK, respectively, provided the units are of the same size and configuration and the production is owned the same; and
- 10. To consider and cover such other matters as the Commissioner of Conservation may deem appropriate and necessary under the circumstances.

The Burgess-Simmons Sand in the Lisbon Field, Claiborne Parish, Louisiana, was defined in Office of Conservation Order No. 9-C, effective November 10, 1945.
