

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, MAY 24, 2011**, upon the application of **SQUARE MILE ENERGY, LLC**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Cris I Zone, Reservoir L and Cib Op Zone, Reservoir A**, in the Larose Field, Lafourche Parish, Louisiana.

1. To establish rules and regulations governing the exploration for and production of gas and condensate from the Cris I Zone, Reservoir L and Cib Op Zone, Reservoir A.
2. To create a single drilling and production unit for each of these zones and reservoirs, such units designated CRIS I RL SUA and CIB OP RA SUA.
3. To force pool and integrate all separately owned tracts, mineral leases and other property interests within each of the proposed units in accordance with Section 10, Title 30 of the Louisiana Revised Statutes of 1950, with each separate tract sharing in unit production on a surface acreage basis of participation.
4. To designate an operator of and unit well for each of the proposed units as may be appropriate.
5. To provide that future wells drilled to the Cris I Zone, Reservoir L or Cib Op Zone, Reservoir A, within or outside of the units proposed herein be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
6. To provide that the Commissioner of Conservation may reclassify the Cris I Zone, Reservoir L and Cib Op Zone, Reservoir A by Supplemental Order and without the necessity of a public hearing should such a reclassification be warranted based on evidence furnished to the Commissioner of Conservation.
7. To consider such other matters as may be pertinent.

The Cris I Zone was previously defined in Office of Conservation Order No. 405-R-5, effective June 19, 2007.

The Cib Op Zone, Reservoir A is defined as that gas and condensate bearing zone encountered between the depths of 12,965' and 14,350' (electrical log measurements) in the Pennzoil Exploration & Production Company-M. R. Fee 852 No. 18 Well, located in Section 37, Township 16 South, Range 20 East.

Plats are available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
