To permit Applicant to drill, designate and utilize its Weyerhaeuser No. 3 Well, located as shown on the plat submitted with the application, as an alternate unit well for the Lower Tuscaloosa Sand, Reservoir C, Sand Unit A, designated L TUSC RC SUA, as per Office of Conservation Order No. 1317-A-5, effective April 6, 2010, which is in compliance with the spacing provisions of Order No. 1317-A-5 and Statewide Order No. 29-E.
- 2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Lower Tuscaloosa Sand, Reservoir C, underlying L TUSC RC SUA, which cannot be efficiently and economically drained by any existing well within the unit.
- 3. To grant a single unit allowable for the L TUSC RC SUA and to permit the operator of the unit to produce said unit allowable from the unit well, the proposed alternate unit well, or from a combination of such wells in the unit, at its option.
- 4. To find that, except to the extent contrary in the order granted by the Commissioner of Conservation in connection with the hearing held on this application, the provisions of Order No. 1317-A-5, effective April 6, 2010, remain in full force and effect.
- 5. To consider such other matters as may be pertinent.

The Lower Tuscaloosa Sand was defined in Order No. 1317-A, effective December 15, 1987.
