Cotton Valley Formation, Reservoir A, CASPIANA  
FIELD, Caddo Parish, Louisiana.

Dear Sir:

INDIGO MINERALS LLC ("Applicant") hereby respectfully applies for a public hearing to consider evidence relative to the issuance of an Order pertaining to the following matters relating to the Cotton Valley Formation, Reservoir A, in the Caspiana Field, Caddo Parish, Louisiana:

1. To authorize Applicant to drill, designate and utilize a horizontal well as an alternate unit well for CV RA SU92, at the location shown on the attached plat, in lieu of two of the vertical alternate unit wells approved by Order No. 191-A-138, effective June 27, 2006, and to approve an exception to the spacing provisions of Office of Conservation Order No. 191-A, effective February 15, 1975, for all productive portions of the wellbore of this horizontal well located at least 330 feet from a unit boundary.

2. To find that the proposed alternate unit well is necessary to efficiently and economically drain a portion of the Cotton Valley Formation, Reservoir A, underlying CV RA SU92 which cannot be efficiently and economically drained by any existing well on such unit.

3. To provide that where the horizontal portion of the well is cased and completed utilizing a "Packer's Plus" or similar method of completion, the distance to any unit boundary and between offset well(s) will be calculated based on the distance to the closest point open to the wellbore.

4. To permit the operator of CV RA SU92 to produce the unit allowable from either the unit well, from the alternate unit well, or from a combination of such wells, at the option of the Operator.

5. Except insofar as set forth above, to confirm and continue in full force and effect the provisions of Office of Conservation Order No. 191-A, effective February 15, 1975, as amended and supplemented by the 191-A Series of Orders, the units created thereby, and of all applicable Statewide Orders.

6. To consider such other matters as may be appropriate and justified by the evidence presented at the hearing.

The Cotton Valley Formation, Reservoir A, in the Caspiana Field, Caddo, DeSoto and Red River Parishes, Louisiana, was initially defined by Office of Conservation Order No. 191-A, effective February 15, 1975, and was redefined as to CV RA SU92 by Order No. 191-A-131, effective April 18, 2006.

Any pertinent data concerning this application will be available for inspection at the offices of Mr. Craig Barclay, 522 Dumbarton, Shreveport, Louisiana 71106. Any person wishing to inspect any such data should call Mr. Barclay at (318) 869-2223 during normal business hours in order to arrange a date and time for such inspection. A copy of any such pertinent data which is not otherwise available from the Office of Conservation can be obtained from Applicant at the expense of the requesting party.


As provided by the Revised Rules of Procedure, the subject matter of this application does not require the issuance of a pre-application notice; therefore, no such notice has been issued.

Applicant will provide for posting of a copy of the Legal Notice of this hearing, and the enclosed plat, at a prominent place in the area affected and will cause publication of the Legal Notice in a newspaper published in the general area of Caspiana Field, all in accordance with the Revised Rules of Procedure. Furthermore, Applicant will mail a copy of the Legal Notice to all Interested Owners, Represented Parties and Interested Parties promptly upon receipt of the Legal Notice from the Commissioner.

Finally, enclosed herewith is our check payable to the Office of Conservation covering the application fee.


