

**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JUNE 7, 2011**, upon the application of **HILCORP ENERGY CORPORATION**.

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **6,500' Sand, Reservoir A**, in the Lafitte Field, Jefferson Parish, Louisiana.

1. To dissolve the LFT 6500 SU, as established by Office of Conservation Order No. 76-G-2, effective April 1, 1968, and simultaneously therewith, to create a single drilling and production unit for the exploration for and production of gas and condensate from the 6,500' Sand, Reservoir A.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created as per the "Unit Agreement" included with Order No. 76-G-2, effective April 1, 1968.
3. To designate a unit operator and a unit well for the unit so created.
4. To provide that the 6,500' Sand, Reservoir A, should be exempt from the spacing provisions of Statewide Order No. 29-E.
5. To provide that the Commissioner of Conservation may reclassify the 6,500' Sand, Reservoir A by Supplemental Order and without the necessity of a public hearing should such reclassification be warranted, based on evidence furnished the Commissioner of Conservation.
6. To consider such other matters as may be pertinent.

The 6,500' Sand, Reservoir A was fully defined in Order No. 76-G-2, effective April 1, 1968.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
