**LEGAL NOTICE**

**STATE OF LOUISIANA, OFFICE OF CONSERVATION, BATON ROUGE, LOUISIANA.**

In accordance with the laws of the State of Louisiana, and with particular reference to the provisions of Title 30 of Louisiana Revised Statutes of 1950, a public hearing will be held in the Hearing Room, 1<sup>st</sup> Floor, LaSalle Building, 617 North 3<sup>rd</sup> Street, Baton Rouge, Louisiana, at 9:00 a.m. on **TUESDAY, JUNE 7, 2011**, upon the application of **EL-OIL LTD.**

At such hearing the Commissioner of Conservation will consider evidence relative to the issuance of Orders pertaining to the following matters relating to the **Sparta Zone, Reservoir A**, in the West Pilgrim Church Field, Allen Parish, Louisiana.

1. To establish rules and regulations and to create a single drilling and production unit for exploration for and production of gas and condensate from the Sparta Zone, Reservoir A.
2. To force pool and integrate all separately owned tracts, mineral leases and other property interests within the unit so created with each tract sharing in unit production on a surface acreage basis of participation.
3. To designate El-Oil, Ltd. operator of the proposed Sp RA SUA and to designate their Powell No. 1 Well as the unit well.
4. To provide that any wells drilled to the above mentioned zone, within or outside of the proposed unit, should be located in accordance with the spacing provisions of LAC 43:XIX.1901 et seq. (Statewide Order No. 29-E).
5. To allow the Commissioner of Conservation to reclassify the reservoir by Supplemental Order, without the necessity of a public hearing should the producing characteristics of the reservoir change and evidence to justify such reclassification is submitted to and accepted by the Commissioner of Conservation.
6. To consider such other matters as may be pertinent.

The Sparta Zone is defined as the gas and condensate bearing zone encountered between the depths of 9,540' and 10,736' (electric log measurements) in the Silver Oak Operating, LLC (South Louisiana Production Company) Powell Lumber No. 1 Well, located in Section 34, Township 5 South, Range 5 West.

A plat is available for inspection in the Office of Conservation in **Baton Rouge** and **Lafayette**, Louisiana.
