

TRACT 33068 - Iberia and St. Mary Parishes, Louisiana

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description and all islands and other lands formed by accretion or reliction, except tax lands, owned by and not under mineral lease from the State of Louisiana on January 10, 2001, situated in Iberia and St. Mary Parishes, Louisiana, within the following described boundaries: Beginning at the Southeast corner of State Lease No. 10835, as amended, having Coordinates of X = 1,894,340.72 and Y = 338,076.00; thence East 6,159.28 feet to a point having Coordinates of X = 1,900,500.00 and Y = 338,076.00; thence South 426.00 feet to the Northwest corner of State Lease No. 16382 having Coordinates of X = 1,900,500.00 and Y = 337,650.00; thence South 4,650.00 feet along the West boundary of said State Lease No. 16382 to its Southwest corner having Coordinates of X = 1,900,500.00 and Y = 333,000.00; thence South 169.87 feet to a point having Coordinates of X = 1,900,500.00 and Y = 332,830.13; thence West 11,545.88 feet to the Southeast corner of State Lease No. 1735 having Coordinates of X = 1,888,954.12 and Y = 332,830.13; thence North 00 degrees 14 minutes 08 seconds East 5,245.91 feet along the East boundary of said State Lease No. 1735 to the Southwest corner of State Lease No. 11282 having Coordinates of X = 1,888,975.69 and Y = 338,076.00; thence East 1,024.31 feet along the South boundary of said State Lease No. 11282 to its Southeast corner, also being the Southwest corner of said State Lease No. 10835, as amended, having Coordinates of X = 1,890,000.00 and Y = 338,076.00; thence East 4,340.72 feet along the South boundary of said State Lease No. 10835, as amended, to the point of beginning, containing approximately 1,389.15 acres, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources, as provided by the applicant. Anything which may affect the acreage, the shape or the location of the tract, such as non-closure of or incorrect X, Y coordinates or title disputed acreage, or which may affect the status of the tract for leasing, such as overlap of prior leases or nominated tracts, or which may affect potential operations on leases taken, such as inclusion in areas under the jurisdiction of the Department of Wildlife and Fisheries, will not be specifically determined unless and until a bid on this tract is accepted by the Mineral Board; which bid will be accepted on a per acre basis and which acceptance will be conditional upon such specific determinations being made. Once a bid is conditionally accepted by the Mineral Board, the staff will, within a period following the date of the lease sale, determine the acreage, shape and location of the potential lease area of the tract, the status for leasing of all or any portion thereof, and any conditions which may affect potential operations thereon. These determinations may render all or a portion of the bid area unleaseable or may increase or decrease the State claimed acreage such that the total bonus/rental ultimately required may either exceed the bonus/rental paid at the lease sale, which will require additional payment by the successful bidder, or allow the successful bidder a refund of excessive payment. The successful bidder will be notified

of the determinations by the staff and given an opportunity to view the bid area acreage, configuration and location as it has been specifically determined. All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description and all islands and other lands formed by accretion or reliction, except tax lands, owned by and not under mineral lease from the State of Louisiana on January 10, 2001, situated in St. Mary Parish, Louisiana, within the following described boundaries: Beginning at a point having Coordinates of X = 1,909,280.00 and Y = 344,100.00, said point also being the Southwest corner of State Lease No. 16586; thence East approximately 4,130 feet along the Southern boundary of said State Lease No. 16586 to its Southeast corner; thence Southerly approximately 1,600 feet on a straight line to the Northeast corner of State Lease No. 16381; thence West approximately 4,130 feet along the North line of said State Lease No. 16381 to a point having Coordinates of X = 1,909,280.00 and Y = 342,500.00; thence North 1,600 feet to the point of beginning, containing approximately **152 acres**, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources, as provided by the applicant. 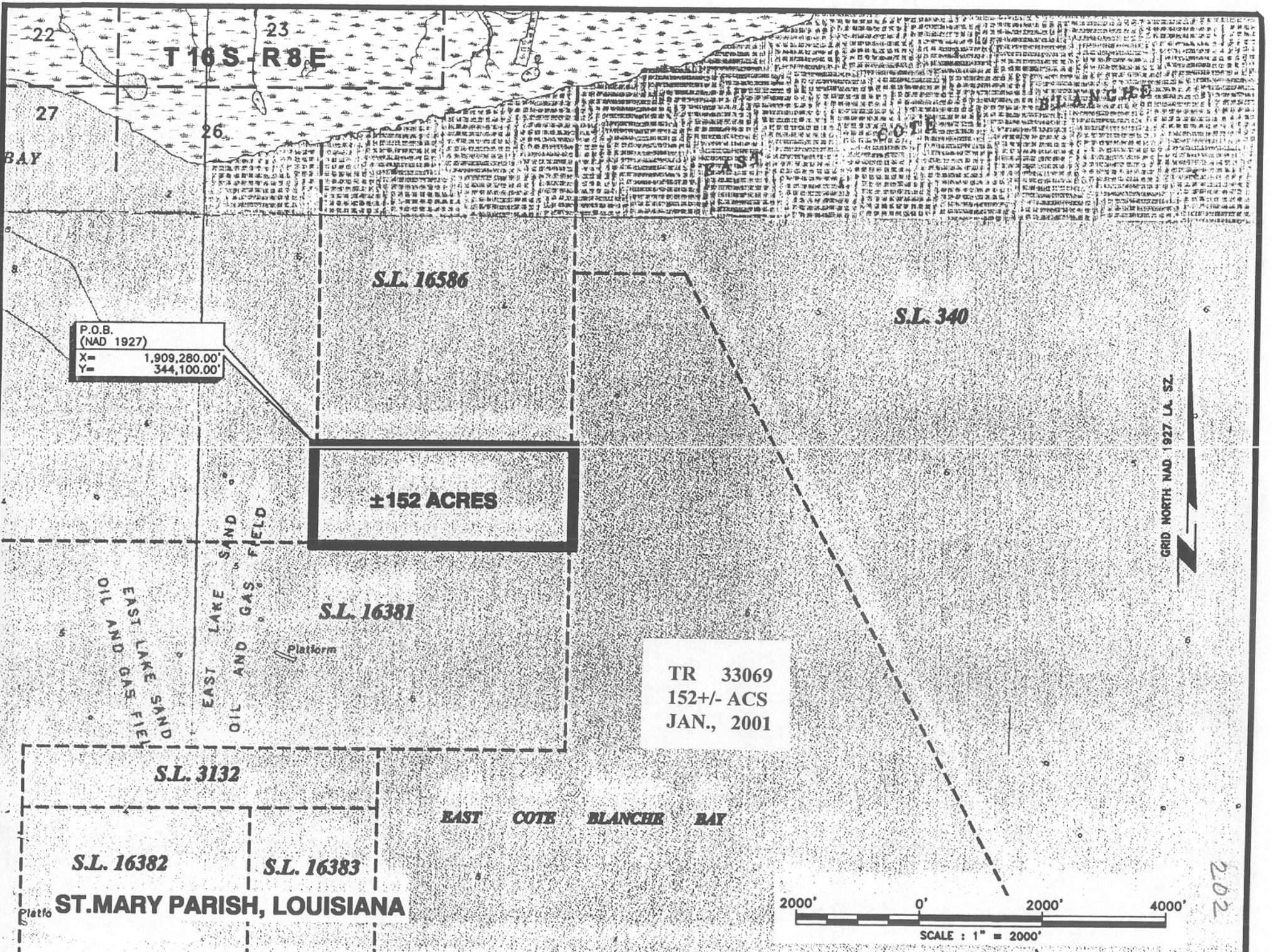
