

**TRACT 33072 - St. Mary Parish, Louisiana**

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description and all islands and other lands formed by accretion or reliction, except tax lands, owned by and not under mineral lease from the State of Louisiana on January 10, 2001, situated in St. Mary Parish, Louisiana, within the following described boundaries: Beginning at the Southeast corner of State Lease No. 13625, as amended, having Coordinates of X = 1,949,500.00 and Y = 310,000.00; thence East 10,999.00 feet to a point having Coordinates of X = 1,960,499.00 and Y = 310,000.00; thence South 8,442.00 feet to a point having Coordinates of X = 1,960,499.00 and Y = 301,558.00; thence West 12,899.00 feet to a point having Coordinates of X = 1,947,600.00 and Y = 301,558.00; thence North 8,442.00 feet to an intersection point on the South boundary of said State Lease No. 13625, as amended, having Coordinates of X = 1,947,600.00 and Y = 310,000.00; thence East 1,900.00 feet along the South boundary of said State Lease No. 13625, as amended, to the point of beginning, containing approximately **2,499.85 acres**, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources, as provided by the applicant. 5. Removal of all structures, facilities and equipment will be required within 120 days of abandonment unless otherwise agreed to in writing by the Department of Wildlife and Fisheries.

6. No activities will be allowed during the hunting season unless authorized by the Department of Wildlife and Fisheries.

7. Prior to submitting applications for wetland permits to Federal and State permitting agencies, the leaseholder shall coordinate project details with the Department of Wildlife and Fisheries. Contact person for the Department of Wildlife and Fisheries will be Mike Windham at (504) 568-5886.
