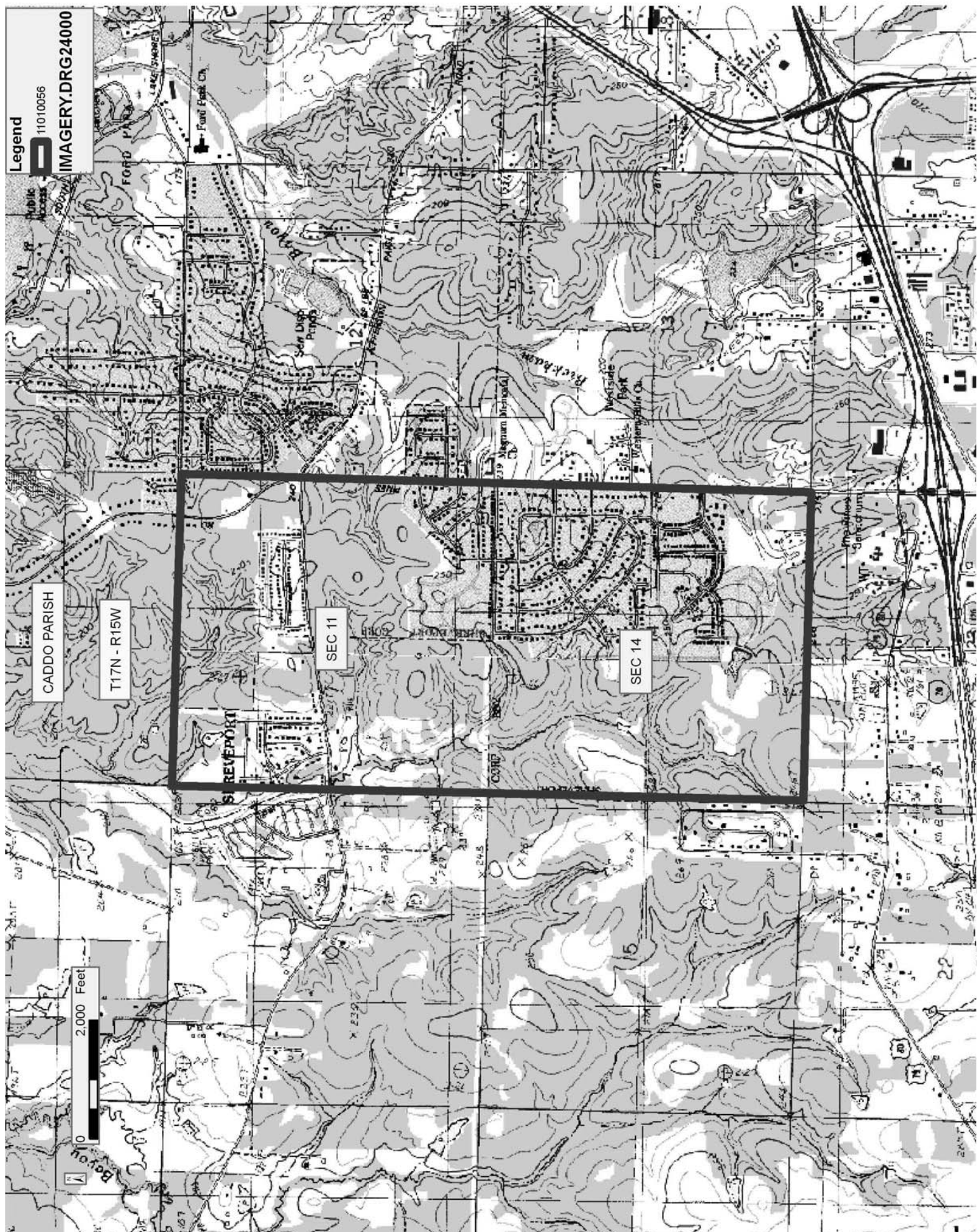

Except as otherwise expressly authorized in writing by Lessor, Lessee, its successors or assigns, may produce oil, gas and other minerals from the leased premises only by drilling from a surface location on other lands.

NOTE: The City of Shreveport will require a minimum bonus of not less than \$5,000.00 per acre and a minimum royalty of not less than 1/4th or 25%.
