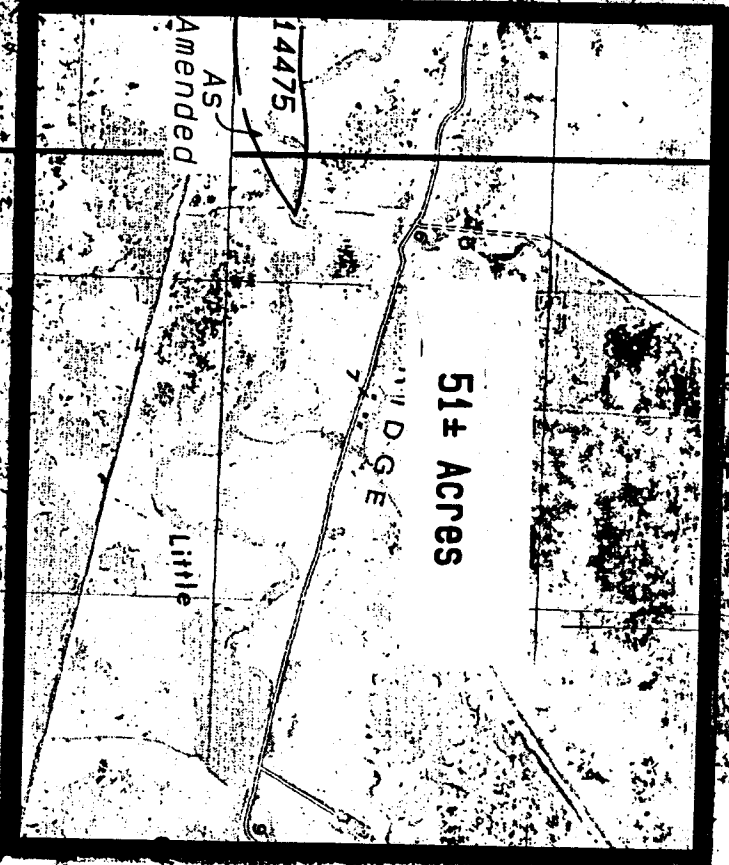

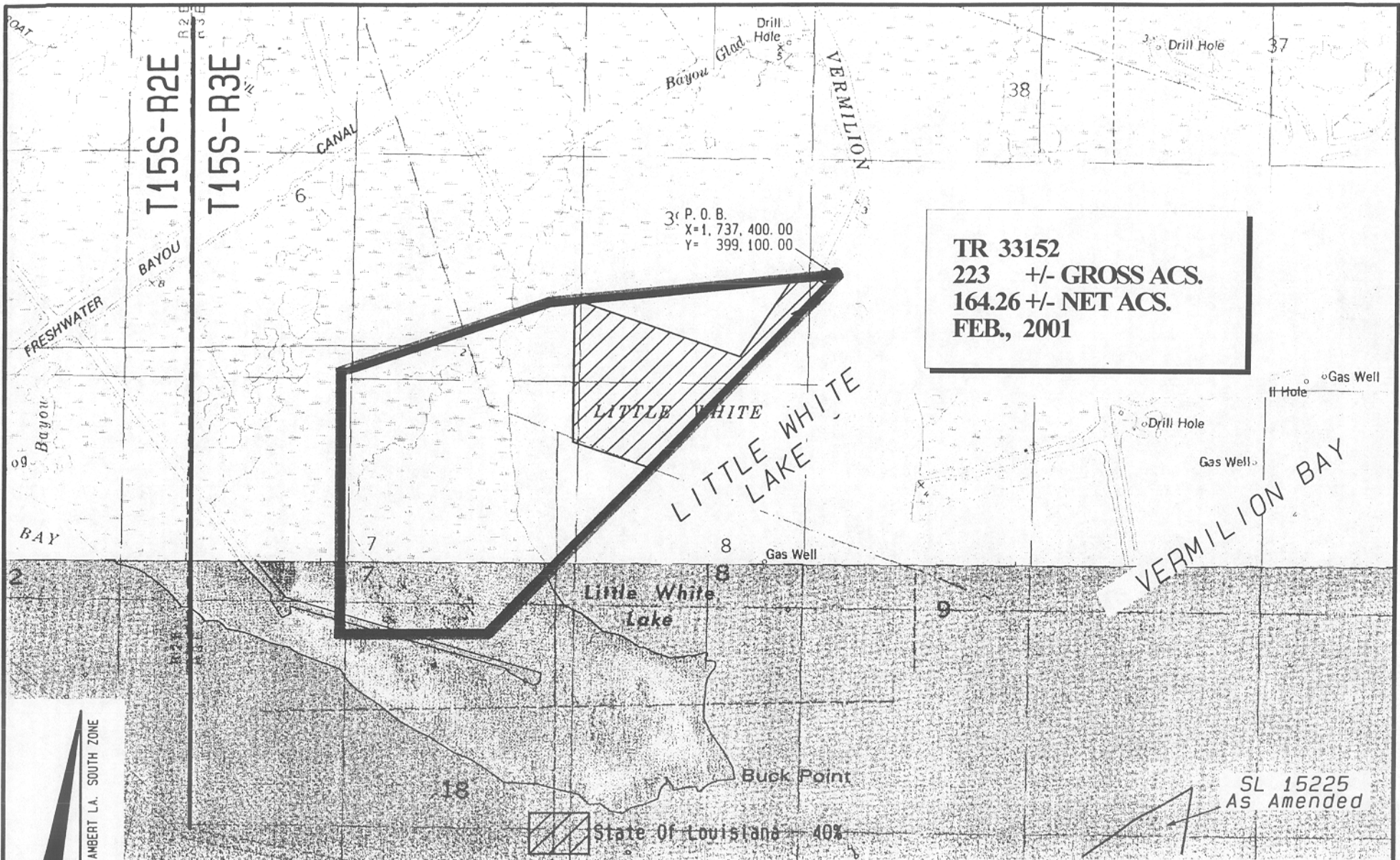

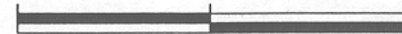
NAD 27 LAMBERT LA. SOUTH ZONE

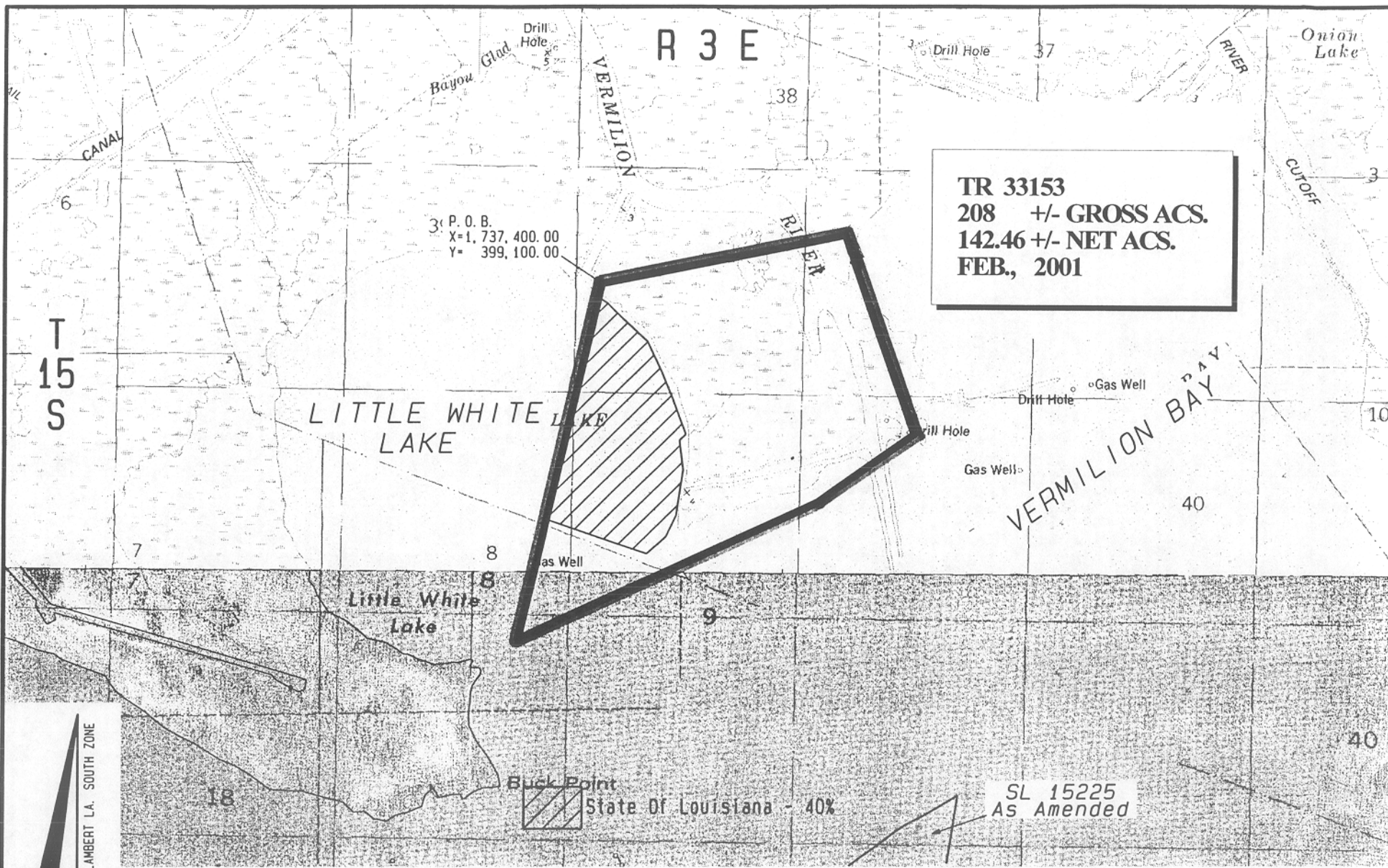

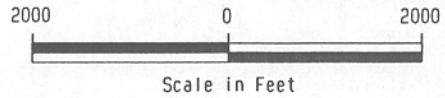
