

**TRACT 37387 - Portion of Block 43, Ship Shoal Area, Terrebonne Parish, Louisiana**

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description the title of which vests in the State of Louisiana, together with all islands arising therein and other lands formed by accretion or by reliction, where allowed by law, excepting tax adjudicated lands, and not presently under mineral lease on May 11, 2005, situated in Terrebonne Parish, Louisiana, and more particularly described as follows: Beginning at the Northwest Corner of Block 43, Ship Shoal Area having Coordinates of X = 2,171,600.00 and Y = 144,896.79; thence East 6,824.88 feet along the North Line of said Block 43 to a point having Coordinates of X = 2,178,424.88 and Y = 144,896.79; thence South 9,231.57 feet to a point on the coastline having Coordinates of X = 2,178,424.88 and Y = 135,665.22; thence Southwesterly on a straight line to the Southeast corner of State Lease No. 17604, having Coordinates of X = 2,175,893.98 and Y = 135,615.38; thence North 32 degrees 37 minutes 11 seconds West 7,965.65 feet along the Northeastern boundary of said State Lease No. 17604 to its North corner located on the West Line of said Block 43 having Coordinates of X = 2,171,600.00 and Y = 142,324.57; thence North 2,572.22 feet along the West line of said Block 43 to the point of beginning, **LESS AND EXCEPT** all that portion of the Isles Dernieres Barrier Island Refuge that lies within the above described tract, containing approximately **1,122.06 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources. 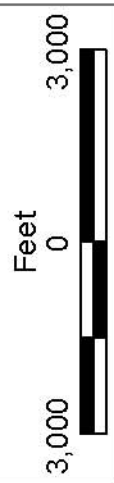
