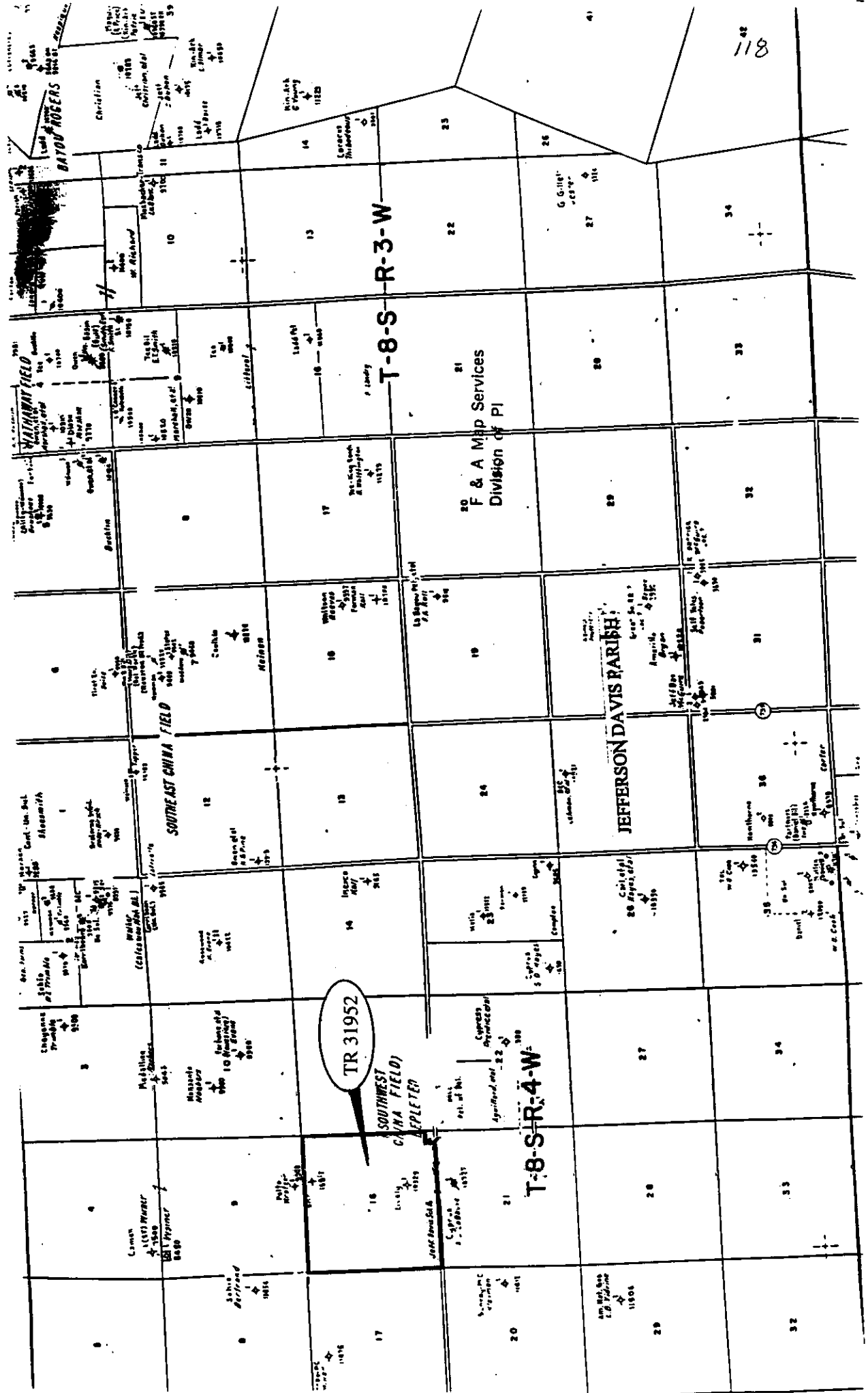

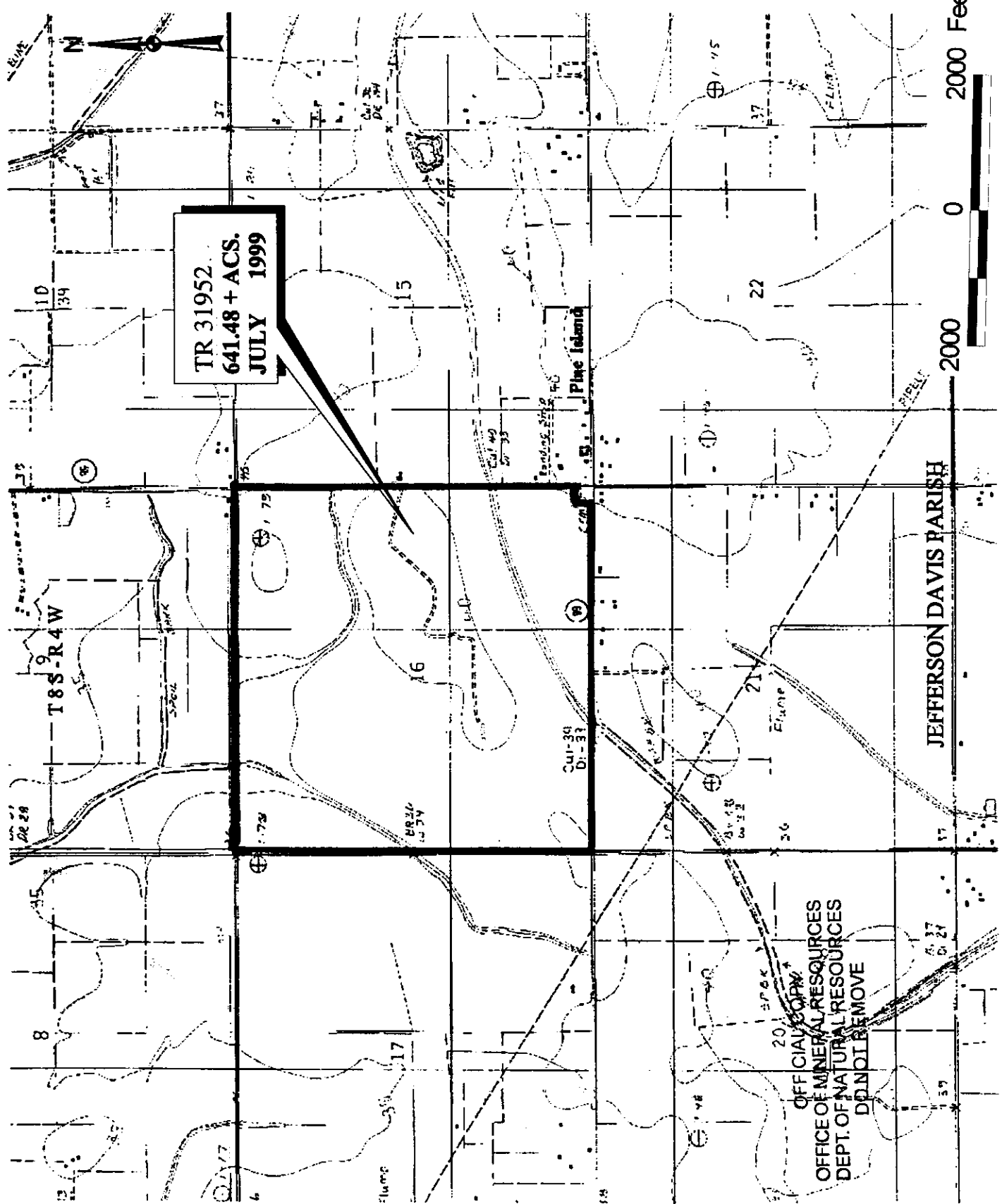

**TRACT 31952 - STATE AGENCY - Jefferson Davis Parish, Louisiana**

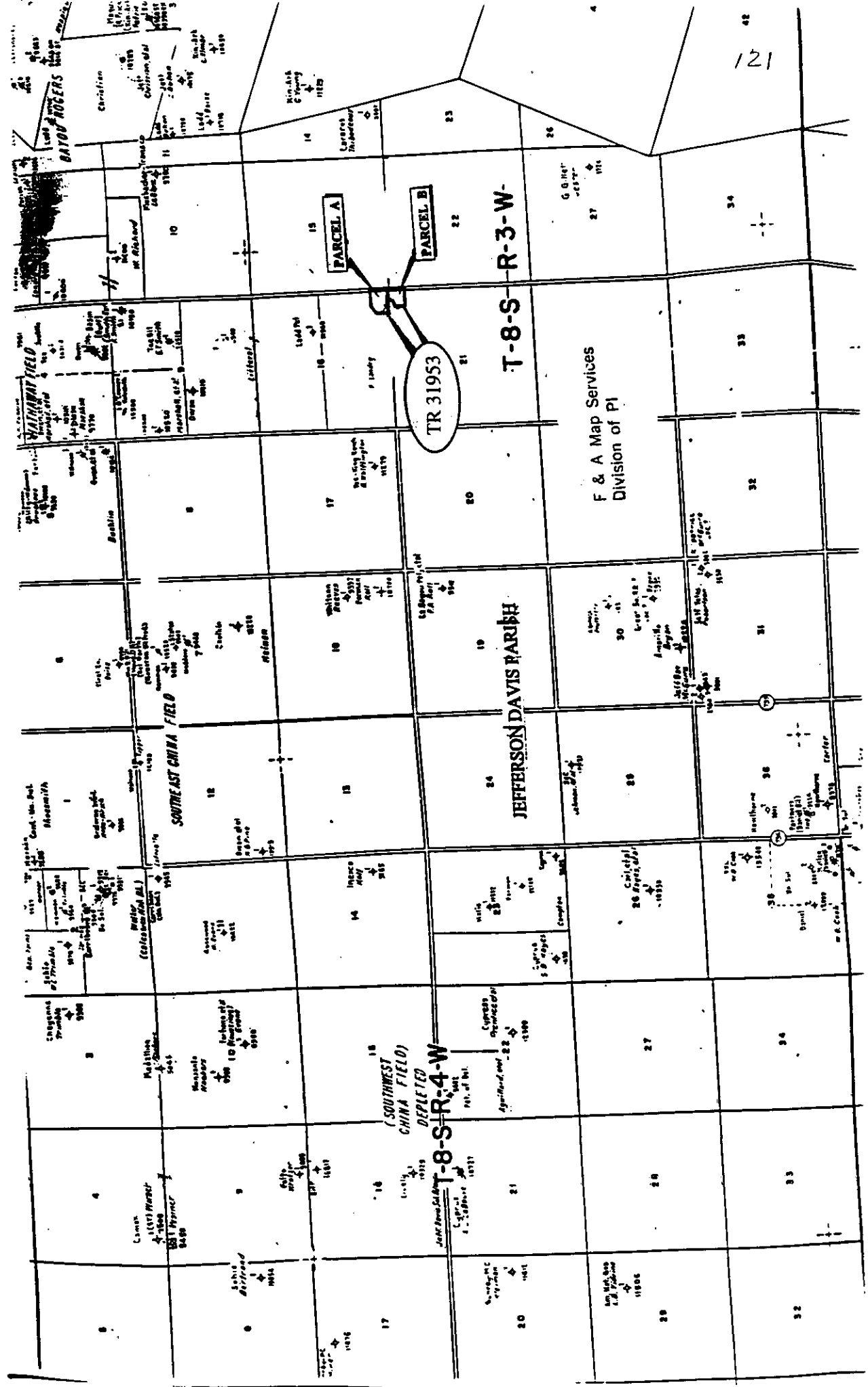

**Parcel B:**

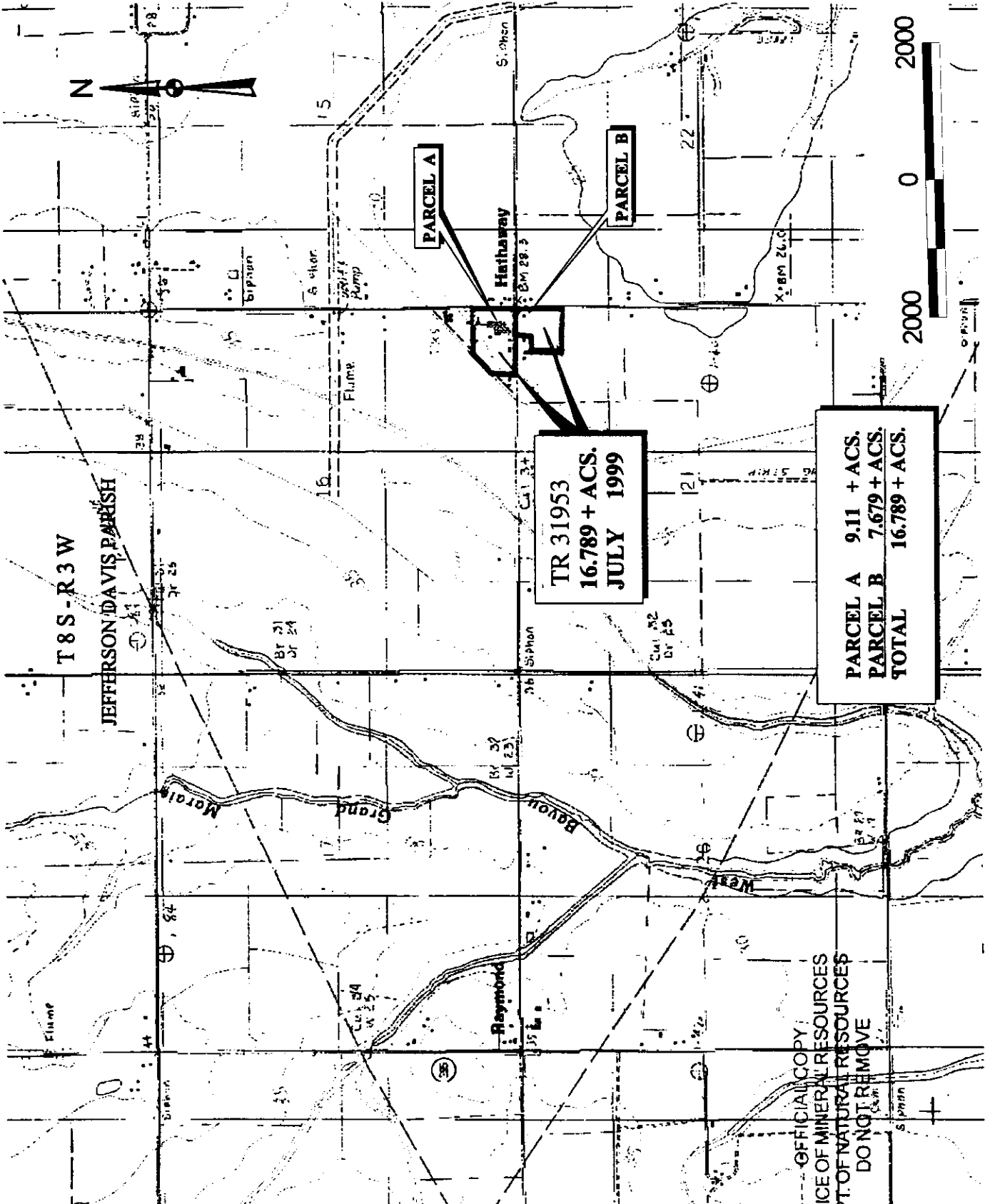
