MAP NOT TO SCALE


TRACT 32749 - STATE AGENCY - Rapides Parish, Louisiana



MAP NOT TO SCALE


TRACT 32750 - STATE AGENCY - Rapides Parish, Louisiana

A certain tract of land belonging to and not under mineral lease from the Rapides Parish Police Jury, on August 9, 2000, being more fully described as follows: A 50 foot strip of land in the R. L. Miller Tract in Section 5, 6, 7 and 8, Township 1 South, Range 2 West, described as follows: corner common to Section 5, 6, 7 and 8, Township 1 South, Range 2 West, run North 89 degrees 03 minutes West 40.1 feet to the point of beginning on the East line of the Richard Miller 1 acre lot; thence run North 00 degrees 43 minutes East 352 feet along the East line of the Richard Miller and Harry Miller lots; thence run South 89 degrees 17 minutes East 50 feet to the East line of the strip herein dedicated; thence run South 00 degrees 43 minutes West 422.9 feet to the North line of State Highway No. 113; thence run North 88 degrees 10 minutes West 50 feet along the North line of State Highway No. 113; thence right turn and run North 00 degrees 43 minutes East 70.1 feet along the East line of the Richard Miller 1 acre lot to the point of beginning, comprising 0.485 acres, all shown on a plat of survey by Daniel D. Sandefur dated September 1, 1964, attached to an Act of Cash Sale of even date herewith by appearers to Harry E. Miller, in Volume 649, Page 266 of the Conveyance Records of Rapides Parish, Louisiana, and being the same land described in that "Act of Dedication" dated October 16, 1964, from Raymond L. Miller and wife Mrs. Nellie Mae Miller in favor of the Parish of Rapides, Louisiana, recorded in Volume 649, Page 264 of the Conveyance Records of Rapides Parish, Louisiana, excluding beds and bottoms of all navigable waters, containing approximately 0.485 acres, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources.
