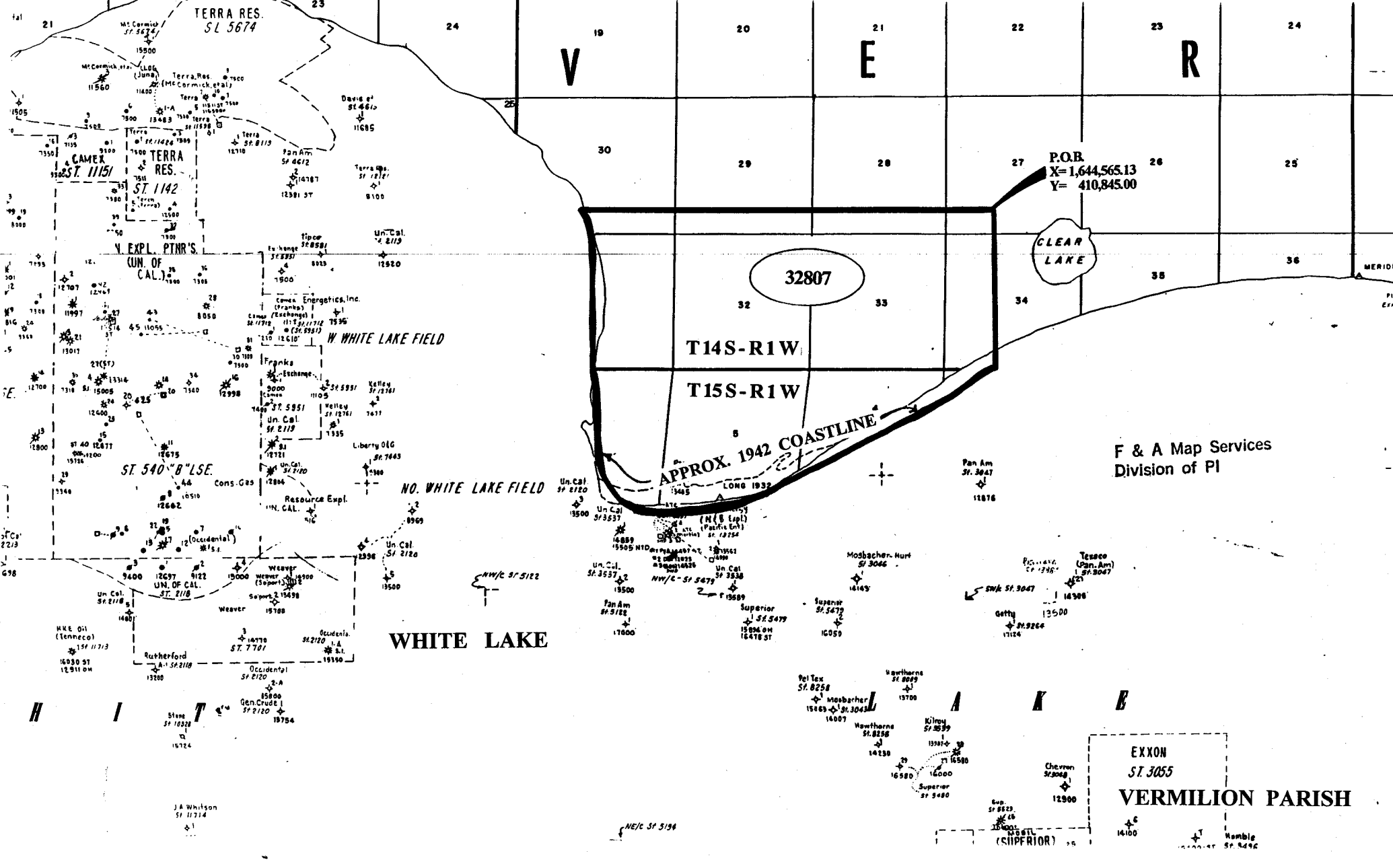

**TRACT 32807 - Vermilion Parish, Louisiana**

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description and all islands and other lands formed by accretion or reliction, except tax lands, owned by and not under mineral lease from the State of Louisiana on September 13, 2000, situated in Vermilion Parish, Louisiana, within the following described boundaries: Beginning at a point having Coordinates of X = 1,644,565.13 and Y = 410,845.00; thence South approximately 5,975 feet to a point of intersection with the 1942 coastline of White Lake; thence Southwesterly, Westerly, Northerly and Northwesterly along said coastline to its intersection with an East-West line having a Coordinate of Y = 410,845.00; thence East approximately 16,375 feet to the point of beginning, **LESS AND EXCEPT** all that portion of White Lake lying South and West of the 1942 coastline of White Lake, containing approximately **200 acres**, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927 (South Zone).

NOTE: Any bid on this tract shall contain, as additional consideration by the bidder, the obligation of the bidder, should a title dispute arise regarding this tract and litigation ensue, to pay to the State, as same may be billed, any and all legal costs incurred by the State of Louisiana in defending its title to the tract up to a maximum aggregate amount of one hundred fifty thousand and no/100 (\$150,000.00) dollars for all leases in the same area, so long as the title issues pertaining to leases are the same. Failure to so include the additional consideration set forth herein may, at the sole discretion of the State Mineral Board, render the bid unacceptable.

NOTE: The State of Louisiana does hereby reserve, and this lease shall be subject to, the imprescriptible right of surface use in the nature of a servitude in favor of the Department of Natural Resources, including its Offices and Commissions, for the sole purpose of implementing, constructing, servicing and maintaining approved coastal zone management and/or restoration projects. Utilization of any and all rights derived under this lease by the mineral lessee, its agents, successors or assigns, shall not interfere with nor hinder the reasonable surface use by the Department of Natural Resources, its Offices or Commissions, as hereinabove reserved.
