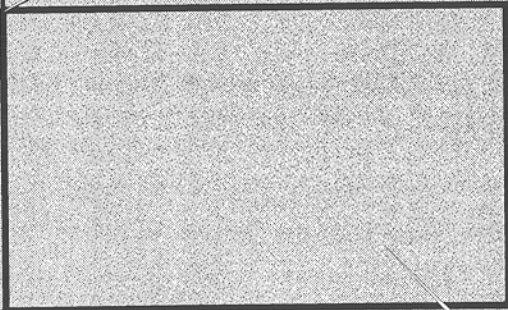

That portion of Block 51, West Delta Area, Plaquemines Parish, Louisiana, belonging to the State of Louisiana and not under mineral lease on September 13, 2000, described as follows: Beginning at a point within Block 51, West Delta Area, being the Southeast corner of State Lease No. 16349 having Coordinates of X = 2,615,455.68 and Y = 147,824.45; thence South 3,148.15 feet to a point on the South boundary of said Block 51 having Coordinates of X = 2,615,455.68 and Y = 144,676.30; thence West 5,192.08 feet along South boundary of said Block 51 to a point having Coordinates of X = 2,610,263.60 and Y = 144,676.30; thence North 3,148.15 feet to a point on the South boundary of said State Lease No. 16349 having Coordinates of X = 2,610,263.60 and Y = 147,824.45; thence East 5,192.08 feet along the South boundary of said State Lease No. 16349 to the point of beginning, containing approximately 375.24 acres, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927 (South Zone).

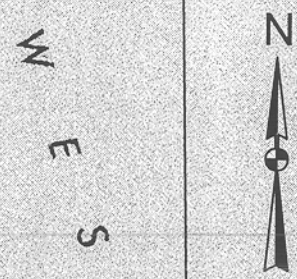

That portion of Block 51, West Delta Area, Plaquemines Parish, Louisiana, belonging to the State of Louisiana and not under mineral lease on September 13, 2000, described as follows: Beginning at a point within Block 51, West Delta Area, being the Southeast corner of State Lease No. 16349 having Coordinates of X = 2,615,455.68 and Y = 147,824.45; thence Northerly on a straight line to a point on the Northern boundary of said Block 51 having Coordinates of X = 2,615,451.75 and Y = 154,695.97; thence North 89 degrees 03 minutes 12 seconds East 3,120.67 feet along the said Northern boundary of said Block 51 to a point having Coordinates of X = 2,618,572.00 and Y = 154,747.52; thence South 10,071.22 feet to a point on the South boundary of said Block 51 having Coordinates of X = 2,618,572.00 and Y = 144,676.30; thence West 3,116.32 feet along the South boundary of said Block 51 to a point having Coordinates of X = 2,615,455.68 and Y = 144,676.30; thence North 3,148.15 feet to the point of beginning, **LESS AND EXCEPT** any portion of State Lease No. 192, as amended, that may lie within the above described tract, also **LESS AND EXCEPT** any portion of State Lease No. 16349 that may lie within the above described tract, containing approximately 718.97 acres, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources.
