

**TRACT 34978 - SCHOOL BOARD - Iberville Parish, Louisiana**

The State Mineral Board acting on behalf of the Iberville Parish School Board, pursuant to Resolution adopted by that body and in accordance with Louisiana Revised Statutes 30:121-136 and 151-156, as amended, and Article XIV, Section 16(A)(9) and (B) of the Louisiana Constitution of 1974, as same may be continued and promulgated in proper statutory form and, further, amended from time to time, advertises the lands not under mineral lease on October 9, 2002, excluding the beds and bottoms of all navigable water bodies located within the following: All of Section 16, Township 10 South, Range 11 East in Lafourche Parish, Louisiana, containing approximately **528.83 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources, as provided by the applicant. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927, (North or South Zone) .

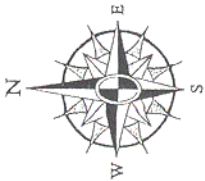
