

**TRACT 35752 - Terrebonne Parish, Louisiana**

All of the lands now or formerly constituting the beds and bottoms of all water bodies of every nature and description the title of which vests in the State of Louisiana, together with all islands arising therein and other lands formed by accretion or by reliction, where allowed by law, excepting tax adjudicated lands, and not presently under mineral lease on October 8, 2003, situated in Terrebonne Parish, Louisiana, and more particularly described as follows: Beginning at a point having Coordinates of X = 2,172,480.00 and Y = 264,010.00; thence South 32 degrees 12 minutes 57 seconds West 18,400.00 feet to a point having Coordinates of X = 2,172,480.00 and Y = 264,010.00; thence West 4,000.00 feet to a point having Coordinates of X = 2,158,670.74 and Y = 248,442.77; thence North 32 degrees 12 minutes 57 seconds East 18,400.00 feet to a point having Coordinates of X = 2,168,480.00 and Y = 264,010.00; thence East 4,000.00 feet to the point of beginning, containing approximately **44 acres**, all as more particularly outlined on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927, (North or South Zone), where applicable.

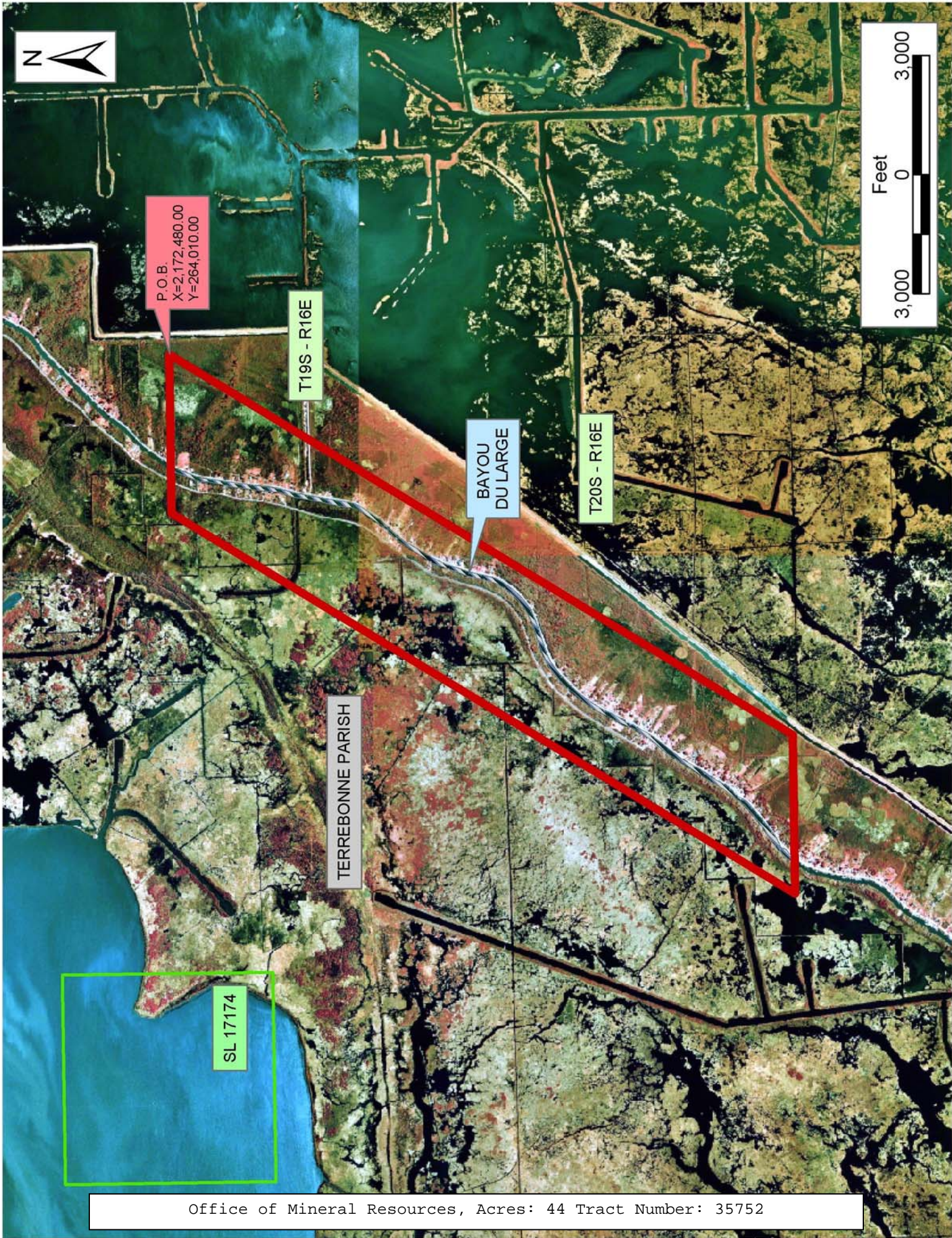
