

TRACT 32390 - PORTION OF BLOCK 4, EAST CAMERON AREA, REVISED, Cameron Parish, Louisiana

That portion of Block 4, East Cameron Area, Revised, Cameron Parish, Louisiana, belonging to the State of Louisiana and not under mineral lease on March 8, 2000, described as follows: Beginning at the Southeast corner of Block 4, East Cameron Area, Revised, having Coordinates of X = 1,509,516.10 and Y = 360,000.00; thence West, 4,258.10 feet along the South line of said Block 4 to a point having Coordinates of X = 1,505,258.00 and Y = 360,000.00, also being the Southeast corner of State Lease No. 15062; thence North, 2,000.00 feet to a point on the South line of State Lease No. 15266 having Coordinates of X = 1,505,258.00 and Y = 362,000.00; thence along the boundary of said State Lease No. 15266 the following courses: East, 1,000.00 feet and North, 4,000.00 feet to a point having Coordinates of X = 1,506,258.00 and Y = 366,000.00, also being the Southwest corner of State Lease No. 15144; thence East, 3,258.10 feet along the South line of said State Lease No. 15144 to its Southeast corner having Coordinates of X = 1,509,516.10 and Y = 366,000.00; thence South, 6,000.00 feet along the East line of said Block 4 to the point of beginning, containing approximately 494.69 acres, as shown outlined in red on a plat on file in the Office of Mineral Resources, Department of Natural Resources. All bearings, distances and coordinates are based on Louisiana Coordinate System of 1927 (South Zone).

NOTE: The State of Louisiana does hereby reserve, and this lease shall be subject to, the imprescriptible right of surface use in the nature of a servitude in favor of the Department of Natural Resources, including its Offices and Commissions, for the sole purpose of implementing, constructing, servicing and maintaining approved coastal zone management and/or restoration projects. Utilization of any and all rights derived under this lease by the mineral lessee, its agents, successors or assigns, shall not interfere with nor hinder the reasonable surface use by the Department of Natural Resources, its Offices or Commissions, as hereinabove reserved.
